REQUESTED ACTION

The New Hampshire Lottery Commission requests to place this item on the Consent Calendar.

The New Hampshire Lottery® Commission (Lottery) respectfully requests authorization to pay membership dues in the amount of \$20,000 to the North American Association of State and Provincial Lotteries (NASPL), Concord, Ohio (Vendor Number #206566). This will be effective upon Governor and Council approval for the period of January 1, 2019 through December 31, 2019. **100% Lottery Funds.**

2. Is there any other organization which provides the same or similar benefits which your agency belongs to? *Not at this time.*





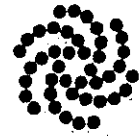
