REQUESTED ACTION

Authorize the Department of Transportation to enter into a contract with Pike Industries, Inc. of Belmont, NH (Vendor 177300) on the basis of a low bid of \$2,128,600.00 for resurfacing of approximately 31 miles in District VI and in Rockingham and Carroll Counties, from the date of Governor and Council approval through October 3, 2014 unless extended by the Department in accordance with the Standard Specifications. 100% Betterment Funds.

EXPLANATION

This project is part of the annual Maintenance District resurfacing. This project involves pavement resurfacing of approximately 31 miles of state highways in the District Six region. The resurfacing will preserve and extend the life of the highway riding surface and protect the subsurface base course materials. All of the proposed work will remain within the right-of-way.

Although the bid costs exceeded the Department's estimate, the low bid is felt to be reasonable for the work involved. Re-advertising this project would result, in our opinion, in higher prices and prevent the completion of the work in a timely manner. Overall, the bids for the district resurfacing program are below estimates. The Department considers it to be in the best interest of the State to accept this bid to accomplish these needed repairs.

The Contractor has been prequalified by this Department. The Contract has been approved by the Attorney General as to form and execution, and the Department has certified that the necessary funds are available. Copies of the fully executed contract are on file at the Secretary of State's Office and the Department of Administrative Service's Office, and subsequent to Governor and Council approval will be on file at the Department of Transportation.

A copy of the Tabulation of Bids received for this project is attached along with the Contract Supplemental Sheet and a map indicating the location of the project.

SUPPLEMENTAL PROJECT INFORMATION SHEET

DESCRIPTION: This project involves resurfacing approximately 31 miles of roadways in District 6. Sections of resurfacing are along NH 1A (Hampton), US 202 (Barrington), NH 108 (Newmarket), Dover Point Rd (Dover), NH 125 (Milton-Wakefield), NH 1A (Rye), Ocean Rd (Portsmouth-Greenland), US 202 (Northwood), NH 126 (Barrington), NH 153 (Farmington-Middleton) and NH 75 (Farmington).

FEDERAL FUNDING: 0% (100% Betterment)

CONTINGENCY: None


PROJECT INITIATED: State's 10-Year Transportation Improvement Program under the "parent" project BRES # 581 (District Betterment Resurfacing Program).

PROJECT EXPLANATION: These roadways are located throughout District 6 and serve various functions. These pavements are in fair to poor condition. The intent of this project is to maintain and improve the riding surface and to extend the life of the existing roadways. All of the proposed work will remain within the right-of-way.

TRAFFIC IMPLICATIONS: Minimal traffic implications are anticipated. Alternating one-way traffic will be allowed only on roads with pavement widths less than forty-four feet. Normal traffic patterns will be re-established prior to the beginning of non-work hours. No work will be permitted from May 23 through May 27, July 3 through July 7 and from August 29 through September 2, 2014. No work on section 6-01, NH 1A (Hampton) and section 6-06, NH 1A (Rye) will take place prior to September 2, 2014. Work on Section 6-04, Dover Point Road (Dover), from NH 16 to Homestead Lane shall be completed at night (6:00 pm to 7:00 am). Work on section 6-08, US 202 (Northwood) shall be completed by July 18, 2014.
