EXHIBIT G to Emergency Order #29

Department of Health and Human Services, May 12th, 2020

Pursuant to Emergency Order #29, which authorizes temporary modification of executive branch deadlines and requirements, issued pursuant to Section 18 of Executive Order 2020-04 as extended by Emergency Orders 2020-05 and 2020-08, the following is hereby ordered:

Continuation of Current Residential Child Care Licenses

1. The expiration of child care agency and child care institution licenses and permits pursuant to RSA 170-E:31, I, III & V are hereby stayed during the State of Emergency and deferred until 90 days after the State of Emergency is lifted.
2. The requirements pursuant to RSA 170-E:31, IV, annual monitoring visits, and RSA 170-E:32, reexamination of child care agencies and child care institutions, for renewal of licenses are hereby stayed until 90 days after the State of Emergency is lifted.

Issuing New and Pending Residential Child Care Licenses

3. The requirement that state and local officials review child care agencies and child care institutions for compliance with state and local requirements pertaining to health, safety, zoning, and state fire code pursuant to RSA 170-E:28 and 170-E:30 are hereby stayed until 90 days after the State of Emergency is lifted.
4. The requirements that applicants provide inspection reports by states and local officials pursuant to He-C 6446.04(c)(3) & (4), He-C 6446.05(b)(1) & (2), He-C 4001.02(c), He-C 4001.02(d), He-C 4001.02(f), and He-C 4001.03 (c)(2) are hereby stayed until 90 days after the State of Emergency is lifted.
5. The requirement that applicants meet with Division representatives or participate in the preparation of a home study pursuant to He-C 6446.04(d)(2) & (3) is hereby stayed until 90 days after the State of Emergency is lifted.
6. The requirements that applicants for foster family care have a fire inspection of the home pursuant to He-C 6446.10(e) and a health inspection of the home pursuant to He-C

6446.10(f) are hereby stayed until 90 days after the State of Emergency is lifted.

7. The requirement that an applicant for foster family care meet with all household members and representatives of the Division prior to issuance of a permit or a license pursuant to He-C 6446.11(a) is hereby stayed until 90 days after the State of Emergency is lifted.
