## **REQUESTED ACTION**

Pursuant to the provisions of RSA 14:30-a, VI, authorize the Department of Health and Human Services, Division of Long Term Supports and Services, to amend an accept and expend item of federal funds approved by the Governor pursuant to RSA 21-P:43, RSA 4:45, RSA 4:47, and Executive Order 2020-04 as extended, to allow DHHS to modify and reallocate the budget by transferring funds in the amount of \$40,000 between classes effective upon Fiscal Committee and Governor and Executive Council approval through September 30, 2022. #### **EXPLANATION**

Funding in this Accounting Unit represents costs associated with APC5 Elder Justice Grant. The grantor, Administration for Community Living, has approved the use of the Elder Justice grant to cover the cost of overtime for APS Intake workers. Funds are needed in Class 018 (Overtime) and Class 060 (Benefits) due to the revision in the grant plan. These two expense classes are new to the accounting unit and not part of the approved budget. Funds are available in Classes 020 (Current Expenses) and Class 069 (Promo & Marketing Expense) due to the grant revision.

The Department has conducted a detailed review of line items in the budget to ensure that available funds are maximized to the greatest degree possible.
