REQUESTED ACTION

EXPLANATION

The Conservation License Plate funding is derived from the sale of conservation license plates. In accordance with RSA 261:97-b, I, proceeds from the sale of conservation license plates is distributed to several state agencies, including the Department of Natural and Cultural Resources (DNCR). Additionally, RSA 261:97-c, I, states that the DNCR funding is to be used to promote the use and conservation of cultural resources in New Hampshire and to preserve the cultural heritage that belongs to all New Hampshire citizens.

In 1999, recognizing that historic barns and agricultural structures symbolize the distinctive New Hampshire values of heritage, hard work, productivity, and stewardship, the Legislature established the Historic Agriculture Structures Advisory Committee (Committee). RSA 227-C:27 further notes that these structures are witnesses to the role of agriculture in our state's image and its economy, and that although they serve as scenic landmarks for residents and visitors alike and are among our most highly valued heritage resources, many can no longer generate sufficient income to prevent their loss by decay or demolition. Shortly thereafter, in order to assist the owners who are making an effort to preserve these irreplaceable assets, the Committee published Preserving Old Barns: Preventing the Loss of a Valuable Resource. The book combined practical sections on maintenance, foundation and structural repair, and resources and references, with beautiful color photography, a history of New Hampshire barns, and inspirational success stories. An immediate hit among barn owners and would-be barn owners, 6,000 copies sold out in the three printings.

Fifteen years later, barn preservation is more popular -- and more needed -- than ever in New Hampshire. The Barn Committee continues its work of providing technical assistance, education and outreach, but lacks one of its best tools, available copies of Preserving Old Barns. This project proposes to expand the first edition's content, particularly sections on timber frame joinery and the working components of barns; update the resources and reference section; create a new cover, and add new barn images by a professional photographer who has joined the cause of barn preservation. The group explored several publishing options, including online publication and on-demand printing, before deciding to publish the second edition in a traditional format.

The funding currently being requested combines funding from several sources; We seek to budget and expend \$7,000 from the Conservation Number Plate Fund and \$10,000 from the Division's Merciful Restoration Fund which has been established in the Barn Preservation Fund to initiate the program support effort from this fund. The Merciful Restoration Fund is a longtime accounting unit within the Division in which proceeds realized through the publication of books authored by Division staff are available to assist with the publication of books on preservation-related New Hampshire topics. Net proceeds from the publication of the second edition of Preserving Old Barns will replenish Merciful Restoration.

We also seek to accept and expend \$6,656 in private donations of which \$3,100 is in pledges committed by the NH Preservation Alliance which is a non-profit historic preservation organization and member of DHR's Historic Agricultural Structures Advisory Committee while \$3,556 is committed and in escrow by the Park Street Foundation, a charitable foundation and fiscal agent for the NH Historic Agricultural Structures Advisory Committee.

Despite positive impacts from preservation work over time, we're still losing almost a barn a day, dairy farms are in crisis and experts are concerned about a big "bubble" of need in the near future because of deferred maintenance.

The Preservation Alliance has \$3,100 in gifts and pledges committed to the project, fundraising continues, and we will forward these donations to the Division to expend on the project.
