The Governor and Council on motion of Councilor Stevens, seconded by Councilor Kenney acted as follows:

#101 Authorized the Division of Fire Standards and Training and Emergency Medical Services to accept and expend \$2,738,541 of American Rescue Plan Act of 2021, State and Local Fiscal Recovery Funds, for the purpose of improving NH's First Responder Recruitment and Training, by adding personnel, training, and facility improvements at the Raymond S. Burton Fire and EMS Facility in Bethlehem, NH. (2)Further authorized to establish one full-time temporary Program Specialist III position to oversee fire and EMS recruitment and retention efforts throughout the State. Effective upon G&C approval through June 30, 2023. **100% Federal Funds. Contingent upon Fiscal Committee approval on November 19, 2021.** 

#102 Authorized the Division of Homeland Security and Emergency Management to accept and expend Pre-Disaster Mitigation Grant funds from the Federal Emergency Management Agency in the amount of \$505,000 for the implementation of a sustained pre-disaster natural hazard mitigation program to reduce overall risk to the population and structures. Effective upon G&C approval through June 30, 2023. **100% Federal Funds. Contingent upon Fiscal Committee approval on November 19, 2021.** 

#103 Authorized the Division of Fire Standards and Training and Emergency Medical Services to accept and expend funds from the Federal Emergency Management Agency in the amount of \$554,782 for the purchase of a new Fire Engine, firefighter training equipment, and certification exam software. Effective upon G&C approval through June 30, 2023. **100% Federal Funds. Contingent upon Fiscal Committee approval on November 19, 2021.** 

#104 Authorized the Division of Homeland Security and Emergency Management to enter into a grant agreement with the Town of Northfield to purchase a generator for their Emergency Operations Center, for a total amount of \$41,725. Effective upon G&C approval through August 31, 2022. **100% Federal Funds.** 

#105 Authorized the Division of State Police to exercise a renewal option of the contract with CI Technologies Inc., St. Augustine, FL (originally approved by G&C on 4-6-16, item #65), for the continue provision of an Internal Affairs Case Management and Tracking System, in an amount not to exceed \$12,163.60, increasing the amount from \$68,937.67 to \$81,101.27 and by extending the end date from December 31, 2021 to December 31, 2033. **100% Federal Funds.** 

#106 Authorized the Division of Homeland Security and Emergency Management to enter into a grant agreement with the Town of Colebrook to update the communications capabilities at Cree Notch for the amount of \$35,000. Effective upon G&C approval through August 31, 2022. **100% Federal Funds.**

#107 Authorized to enter into a subgrant totaling \$500,000 with the Portsmouth Police Department, for the purpose of enhancing and sustaining the NH Internet Crimes Against Children Task Force. Effective **retroactive** to July 1, 2021 through June 30, 2023. **100% General Funds.** 

#108 Authorized to amend, **retroactive** to October 1, 2021, an existing subgrant with the Manchester Police Department (originally approved by G&C on 7-1-19, item #68A), from the US Department of Justice, Bureau of Justice Assistance, Supporting Innovations Grant, by extending the end date only from September 30, 2021 to September 30, 2022. No Additional Funding.

#109 Authorized to enter into a subgrant, totaling \$200,000, with the Portsmouth Police Department, from the American Rescue Plan Act of 2021, for the purpose of supporting internet Crimes Against Children program activities related to relaxed COVID-19 restrictions. Effective **retroactive** to May 28, 2021 to February 28, 2022. **100% General Funds.** 

#111 Authorized the Bureau of Graphic Services to enter into a contract with Budget Business Machines, Lewiston, ME, for Color Production Digital Printer, lease and services, with a price limitation of \$154,000. Effective upon G&C approval through December 31, 2026. **100% Agency Income.**

The Governor and Council on motion of Councilor Warmington, seconded by Councilor Kenney, authorized to enter into a **Sole Source** contract with Vault Medical Service, P.A., Dobbs Ferry, NY, in an amount not to exceed \$8,000,000 for at-home COVID-19 testing, with the option to renew for up to two (2) additional years, effective upon Governor and Council approval through June 30, 2022. **100% Federal Funds.** (2)Further authorized to make unencumbered payments in the amount of \$1,000,000 for at-home COVID-19 testing until such time the Federal Emergency Management Agency (FEMA) reimbursement rate drops below 100%. **100% Federal Funds**.

#### **DEPARTMENT OF TRANSPORTATION**

B. The Governor and Council on motion of Councilor Warmington, seconded by Councilor Kenney, authorized to enter into a contract with Casella Construction, Mendon, VT, on the basis of a low bid of \$2,638,500.50 on an emergency roadway repair project on NH 12 in Charlestown. This authority is being requested in advance in order to expedite the start of construction and minimize the duration of the closure of NH12. The DOT will bring forward a fully executed contract at a subsequent Governor and Council meeting.
