

BOARD OF AUCTIONEERS MINUTES

December 7, 2015, 9:00 a.m.

1. The Board of Auctioneers convened at 9:00 a.m. with, Chairman Russell R. Abbott, Vice-Chairman Roy W. Tilsley, Secretary Gregory J. Walsh, Member Robert P. Secord, and Member Gregory J. Peverly present.
2. The Board on motion of Roy W. Tilsley, seconded by Gregory J. Peverly accepted the minutes of the November 2, 2015 meeting.

8. The Board on motion of Roy W. Tilsley, seconded by Robert P. Secord, authorized the application of Kevin Teets for an Auctioneers License.

10. The Board on motion of Gregory J. Walsh, seconded by Gregory J. Peverly, and further on a roll call vote as follows: Russell R. Abbott – yes, Roy W. Tilsley – yes, Gregory J. Walsh – yes, Robert P. Secord – yes, and Gregory Peverly - yes, voted to go into non-public session to discuss matters under RSA 91-A, specifically, matters which would likely adversely affect the privacy of individuals and or matters in which litigation has been threatened against the Board.

12. The Board did not find sufficient evidence to merit a hearing on the complaint made by Bett Chase. The Board on motion of Roy W. Tilsley, seconded by Robert P. Secord, voted to dismiss the complaint.
