REQUESTED ACTION

EXPLANATION

These transfers reflect adjustments to various expense accounts to address projected expenses in the DAS Division of Plant & Property. Anticipated expenditure patterns for FY 2019 have been analyzed and taken into consideration when projecting expenditures through June 30, 2019. Based upon this review, a number of accounts were found to require additional funds, while other accounts will experience less than what has been appropriated. This transfer will provide for the continued efficient operation of the Department.

The following is the information specifically required when transfers are requested, in accordance with the Budget Officer's instructional memorandum dated April 17, 1985, to support the above requested actions.

> A. Justification: The transfer consists of transfers to cover projected deficits in <u>Facilities-Assets</u> <u>Management</u> class 018 overtime, class 020 current expenses, class 050 personal service temp, and class 070 in-state travel, due to the amounts appropriated being lower than anticipated expenditures; funds are available to cover these deficits in class 022 rents-leases, class 030 equipment, and class 048 contractual maintenance, due to the amounts appropriated being higher than anticipated.

In the <u>Bureau of Court Facilities</u>, transfers are needed to cover projected deficits in class 018 overtime, class 048 contractual maintenance, and class 103 contracts for op services due to the amounts appropriated being lower than anticipated expenditures; funds are available to cover these deficits in class 022 rents-leases, class 023 utilities, class 030 equipment, class 039 telecommunications, and class 050 personal service temp, due to the amounts appropriated being higher than anticipated.

In <u>General Services Maintenance & Grounds</u>, transfers are needed to cover projected deficits in class 018 overtime, class 020 current expenses, class 023 utilities, and class 070 instate travel due to the amounts appropriated being lower than anticipated expenditures; funds are available to cover these deficits in class 048 contractual maintenance and in the Lakes Region Campus and Dube Building Accounting Unit classes 023 utilities, 030 equipment, 039 telecommunications, 047 own forces maintenance, 048 contractual maintenance, 048 contractual maintenance, 050 personal service temp, 060 benefits, and 103 contracts for op services, due to the amounts appropriated being higher than anticipated.

- B. Does this transfer involve continuing programs or one-time projects? This transfer involves continuing programs;
- C. Is this transfer required to maintain existing program levels or will it increase the program level? This transfer is required to maintain existing program levels;
- D. Cite any requirements which make this program mandatory. RSA 21-1:11, I. (c) (1), (5) and (6)
- E. Identify the source of funds on all accounts listed on this transfer. Transfer from Other Agency, Agency Income and General Funds see attached worksheet for percentage details;
- F. Will there be any effect on revenue if this transfer is not approved? There is no anticipated effect on revenue as a result of this transfer;
 - G. Are funds expected to lapse if this transfer is not approved? It is anticipated that some funds will lapse whether this transfer is approved or not;
 - H. Are personnel services involved? All transfer of funds into Class 018 Overtime and Class 050, Part Time Salaries, are to support existing budgeted positions and not for the creation of any new positions.

The Department has conducted a detailed review of these line items in the budget to ensure that available funds are maximized to the greatest degree possible.
