Pursuant to RSA 230:14, attached hereto is a Petition for a hearing on the proposed construction of two roundabouts on US 202 in the Town of Jaffrey.

Since the Petition is not for the limitation or control of access, a Commission of Three Persons should be appointed by the Governor, with the advice of the Executive Council, to hold a hearing. The Commission of Three shall determine whether there is occasion for the construction of the roundabout as presented at the hearing.


To His Excellency, the Governor, and the Honorable Executive Council:

I, Victoria F. Sheehan, Commissioner of the New Hampshire Department of Transportation, in accordance with RSA 230:14, propose the construction of two roundabouts on US 202 in the Town of Jaffrey.

**JAFFREY, 16307, X-A001 (234)**

This project will reduce congestion and address safety issues within the central business district of Jaffrey. US 202 currently intersects with NH 124 and NH 137 at two closely spaced signalized intersections. This project proposes to construct a five-leg roundabout at the intersection of Peterborough Street, Main Street, Blake Street, Stratton Road and Turnpike Road. US 202 would be relocated from Main Street to Blake Street and continue on a new southwesterly alignment over the Contoocook River and intersect with the existing US 202 and School Street at a proposed three-leg roundabout. This project may impact historic properties.

Therefore, I, Victoria F. Sheehan, Commissioner of the New Hampshire Department of Transportation, in accordance with RSA 230:14, propose the construction of a five-leg roundabout at the intersection of Peterborough Road, Main Street, Blake Street, Stratton Road and Turnpike Road in the Town of Jaffrey.
