EXPLANATION

Approval of this payment to Sunrise County Economic Council will allow the Department to receive technical assistance for the Whole Families Approach to Jobs Initiative. A Whole Family Approach to Jobs is a two-year initiative to help participating state leaders develop program, policy and system solutions that support parents in achieving greater employment gains and economic stability. Whole Families Approach to Jobs looks at the "cliff effect," which is the situation for a family when wages alone do not equally make up for the loss of public benefits for working families

The project brings together public and private sector stakeholders across workforce development, human services and education to identify policy opportunities, lessons learned and challenges faced by states seeking to implement whole-family approaches to economic opportunity that benefit parents and families who are low-income. Collaborative teams of multisector stakeholders are working together with support from the National Conference of State Legislatures (NCSL) and in collaboration with the Administration for Children and Families (ACF) Region I. In New Hampshire, employers, parents, charitable foundations, health organizations, community agencies and other state agencies are involved in the initiative. By bringing together the organizations that have a stake in the health and prosperity of the mutual families we serve, coordinated policies and efforts can benefit all.

Listed below are answers to standard questions required for Governor and Executive Council organization dues and membership approval submissions:

- 1. How long has this organization been in existence and how long has this agency been a member of this organization?
 - A. Sunrise County Economic Council was founded in 1993 by a group of business and community leaders. This request, if approved, will pay the Department's intitial membership fee through December 31, 2020.
- 2. Is there any other organization which provides the same or similar benefits which your agency belongs to?
 - A. No.
- 3. How many other states belong to this organization and is your agency the sole New Hampshire state agency that is a member?
 - A. New England States are members. If this request is approved, the Department will be only New Hampshire state agency that is a member.
- 4. How is the dues structure established? (Standard fee for all states, based on population, based on other criteria, etc.)
 - A. The flat annual fee for New England states interested in joining this initiative as members is \$10,000/year, regardless of size of population, state budget, or other variable factors.
- 5. What benefit does the state receive from participating in this membership?
 - A. Sunrise County Economic Council is the fiscal agent for the Whole Family Approach to Jobs Initiative. In this role they will provide, through a network of regional and national consultants skilled in this field, technical assistance to the State of New Hampshire related to the Whole Family Approach to Jobs Initiative and the support the work and research on the cliff effectf working families can experience. This Initiative is a partnership between the State of New Hampshire, Region 1 Administration for Children and Families, and the National Conference of State Legislatures. Technical assistance, as requested by DHHS, may include:
 - Planning and facilitation of multi-stakeholder meetings to identify and move

forward policies to improve outcomes for New Hampshire families.

- Research and analysis on policies related to benefits cliffs and other policies impacting families' opportunities to succeed in employment.
- Research and identification on model practices on the program or systems level.
- Identifying and making connections to national or regional expertise, as requested by the New Hampshire Whole Family Approach to Jobs team.
- Consultants on family engagement to assist within state and community agencies to assure consumer input into program and policy and to utilize family narrative to help inform innovation.
- Collaboration with other New England states on family policies and practices at the state and federal level.
- 6. Are training or educational/ research materials included in the membership? If so, is the cost included? Explain in detail.
 - A. Training and educational/research materials are included in the cost of membership. Examples include: Reports from other jurisdictions undertaking projects and initiatives related to the Whole Families Approach effort.
- 7. Is the membership required to receive any federal grants or required in order to receive or participate in licensing or certification exams? Explain.
 - A. No however, the state is able to access information and resources that support efforts to maximize state and federal resources and provide high quality services.
- 8. Is there any travel included with this membership fee? Explain in detail any travel to include the number of employees involved, the number of trips, destination if known and purposes of membership supported trips.
 - A. No.
