#### REQUESTED ACTION

Authorize the Department of Health and Human Services, Division of Medicaid Services, to **retroactively** pay the MEDICAID|MEDICARE|CHIP Services Dental Association ("MSDA"), 2 Grove Street, Sandwich, MA 02563, (Vendor # 225831-B001), in the amount of \$3,500 for annual membership dues effective retroactive to July 1, 2019, upon Governor and Executive Council approval through June 30, 2020. 75% Federal Funds, 25% General Funds.

### **EXPLANATION**

This request is **retroactive** because the funds to support this membership were not available during the continuing resolution. Approval of this request will enable State personnel responsible for Medicaid/CHIP Dental Program policy and administration to receive education, training and technical assistance.

The mission of the MEDICAID|MEDICARE|CHIP Services Dental Association (MSDA) is to improve Medicaid, Medicare, and CHIP oral health programs by collaborating with key stakeholders, sharing resources, and disseminating innovative strategies.

  - The Association was founded in May of 2004, in Los Angeles, California, at a meeting for Medicaid representatives. Attendees voted to form an association that would advocate for the delivery of oral health care to the Medicaid-eligible population.

  - Technical assistance initiatives and skills-building programs.
