## **REQUESTED ACTION**

Pursuant to RSA 14:30-a, VI, authorize the Department of Administrative Services, Division of Procurement and Support Services, Bureau of Purchase and Property, Surplus Distribution Section, to budget and expend prior year carry forward funds in the amount of \$192,440.00 available in the Surplus Food Operating Account which will be used to replace a refrigerated box truck and an electric powered forklift both of which have passed their usable lifecycles, effective upon Fiscal Committee and Governor and Council approval through June 30, 2019. **100% Agency Income.**

## **EXPLANATION**

Locally, the program is administered, warehoused, and distributed by the Department of Administrative Services, Surplus Distribution Section.

The Department of Administrative Services is requesting to budget and expend \$192,440.00 in funds carried forward from FY2018 into FY2019.

The funds in class 030 Equipment New/Replacement will be used to purchase a replacement refrigerated box truck complete with a lift gate and a replacement forklift. The current truck is a 2006 model and has over 250,000 miles. The current forklift is a 2002 model and is no longer functioning properly. Both the truck and the forklift will be turned in to Surplus Property and the proceeds from the sales will be put back into the Surplus Food Program.
