

#### **REQUESTED ACTION**

That approval be and hereby is given to the Attorney General to designate Lisa Wolford, (Position #9U540, Appropriation #02-20-200510-2610-013-500132) as an Assistant Attorney General at a salary level of \$67,906.80. Ms. Wolford is occupying a position for a five-year term, effective upon Governor and Executive Council approval through August 13, 2023.

#### **EXPLANATION**

Ms. Wolford is a resident of Portsmouth and is a member of the New Hampshire Bar. She graduated from Cornell Law School in 2002 and received her undergraduate degree from Wellesley College in 1986 *cum laude*. Ms. Wolford was appointed as an Attorney with the Department of Justice in June 2012 and appointed to Assistant Attorney General in August 2013. In September, 2017, she was named Senior Assistant Attorney General and Bureau Chief of the Criminal Justice Bureau. She has recently returned to the Appellate Unit to focus on criminal appeals. From 2002 to 2012, she was a New Hampshire Public Defender at both the trial and appellate levels and was a member of the Appellate Defender Office for three years. A copy of her resume is attached.

2001 Laws of NH Chapter 158 amended RSA 94:1-a(I)(c)(3) to provide that designation of positions, salary levels, and salary increases for attorneys at the Department of Justice shall be determined by the Attorney General, subject to approval of the Governor and Council, within appropriations made to the Department of Justice.
