REQUESTED ACTION

Pursuant to RSA 4:8, the Office of Professional Licensure and Certification respectfully requests authorization to accept a gift for registration reimbursement, not to exceed \$1,995, from the National Association of State Boards of Pharmacy (NABP) to allow one pharmacy compliance inspector to attend the Sterile Compounding Inspection Training at the CriticalPoint Center for Training and Research (CCTR) in Totowa, NJ from July 11, 2022, through July 15, 2022.

EXPLANATION

The National Association of Boards of Pharmacy (NABP) is a 501(c)(3) nonprofit organization that supports and works with its members to protect the public health. New Hampshire is a long-time member of NABP. CriticalPoint's Sterile Compounding Inspection Training (SCIT) program covers all aspects of sterile compounding, including hands-on exercise in hand hygiene and garbing; environmental sampling, aseptic technique and first air; and bubble point and sterility testing. Additionally, participants will gain an understanding of the "whys" behind the "whats" of United States Pharmacopeia Chapters <797> and <800> in addition to being exposed to some of CriticalPoint's best practices. Participants who timely complete the Sterile Compounding eLearning Series and corresponding posttests, attend the live training, and successfully pass the final posttest will earn the NABP/CriticalPoint Certification in Sterile Compounding for Inspectors (CISCI).

The State of New Hampshire has been offered a scholarship from NABP to cover the registration cost to send one OPLC pharmacy compliance inspector to this valuable SCIT program from July 11 through July 15, 2022, in Totowa, NJ with funds being made available through the NABP. Registration includes light breakfasts, snacks, and lunches, as well as shuttle transportation to the airport and to and from the conference hotel and CCTR. Attendees will be responsible for meals and travel outside of what is included. Discounted rates for the hotel and airport-to-hotel transportation are available. These additional funds accrued by the attendee would be reimbursed from agency funds.


