

Your Excellency and Members of the Council:

#### REQUESTED ACTION

That approval be and hereby is given to the Attorney General to appoint Takhmina Rakhmatova Position #9U216 (Appropriation #02-20-201010-2620-013-500132) as an Assistant Attorney General at a salary level of \$66,000, effective upon Governor and Executive Council approval, for a term ending on July 31, 2023.

#### **EXPLANATION**

Ms. Rakhmatova is an Auburn resident. In June 2012, she earned her undergraduate degree in Commercial Law, summa cum laude, from the University of Westminster in Tashkent, Uzbekistan. She received her Juris Doctor from Suffolk University Law School in 2018. During law school she served as a Judicial Intern to the Honorable Stephen Limon (Ret.) at Suffolk County Juvenile Court, and a Legal Administrative Assistant at Lathrop Gage, LLP. Ms. Rakhmatova practiced as a Student Attorney, certified under Supreme Judicial Court Rule 3:03, at the Suffolk University Law School Intellectual Property and Entrepreneurship Clinic between August 2017 and May 2018. She is admitted to practice law in New Hampshire, New York, and Massachusetts. Ms. Rakhmatova joined the New Hampshire Department of Justice in July 2019 and has been working in the Civil Bureau as legal counsel for state executive agencies in the procurement, negotiation, and development of contracts, pursuant to RSA 21-M:11, III. Her salary will increase by \$3,000, from \$63,000 to \$66,000. I plan to continue her current assignment. A copy of her resume is attached.
