REQUESTED ACTION

1. Authorize the Department of Transportation to enter into a contract with Roadsafe Traffic Systems, Inc. (Vendor 172436) of Avon, MA on the basis of a single bid of \$467,333.71 for sign replacement along Turnpike facilities in Merrimack, Hooksett, Greenland, and Dover from the date of Governor and Council approval through July 31, 2015 unless extended by the Department in accordance with the Standard Specifications. 100% Turnpike Funds.

2. Further authorize that a contingency in the amount of \$23,366.68 be approved for payment of latent conditions, which may appear during the construction of the project. The contingency requested is 5% of the contract amount.

EXPLANATION

This project is part of the Turnpike Renewal and Replacement Program. This project addresses signing needs and deficiencies at four locations on the Turnpike System. The work involves signing at the Exit 11 interchange in Merrimack, in the vicinity of the Hooksett Welcome Center, along I-95 in Greenland, and on the Spaulding Turnpike in Dover. The existing signage at the Exit 11 interchange in Merrimack has been in place since 1988 and does not meet retroreflectivity or MUTCD requirements. The existing Hooksett Rest Area signs will not meet the needs of the expanded and redeveloped facilities. There are no UNH guide signs along I-95 NB; signage of this nature is warranted. The existing Sixth Street overpass bridge-mounted dynamic message sign on the Spaulding Turnpike is not functioning and needs replacing. All signage included in this contract will improve awareness and safety of travelers.


Although there was only one bid received and the bid costs exceeded the Department's estimate, this bid is felt to be reasonable for the work involved. An aggressive schedule for implementation of the Hooksett Welcome Center signing, as well as the technical nature of the dynamic message board in Dover impacts the ability of potential bidders to respond to the contract requirements. In particular, the costs for bridge mounted traffic signs and permanent dynamic message signs were higher than estimated but are still felt to be reasonable. Re-advertising this project would result, in our opinion, in higher prices and prevent the completion of the work on the schedule required.

The contingency amount is proposed to be 5% of the contract amount. This contract has the potential for unanticipated signage needs due to varying field conditions (soil and soil characteristics) which may impact sign foundation designs.

The Contractor has been prequalified by this Department. The Contract has been approved by the Attorney General as to form and execution, and the Department has certified that the necessary funds are available. Copies of the fully executed contract are on file at the Secretary of State's Office and the Department of Administrative Service's Office, and subsequent to Governor and Council approval will be on file at the Department of Transportation.

A copy of the Tabulation of Bids received for this project is attached along with the Contract Supplemental Sheet and a map indicating the location of the project.

SUPPLEMENTAL PROJECT INFORMATION SHEET

DESCRIPTION: This project consists of addressing signing needs along turnpike facilities at four (4) locations, as follows:

1. Exit 11 Interchange signing on F. E. Everett Turnpike—Replacement of roadway guide signs in Merrimack
2. Hooksett Welcome Center Signs along I-93—Replacement of eight (8) general service/guide signs in Hooksett and Bow
3. UNH sign along I-95 NB—Installation of ground-mounted guide sign in Greenland
4. Dynamic message sign work on Spaulding Turnpike—Replacement of sign at Exit 6 Interchange (Sixth Street) on SB barrel in Dover

FUNDING: 100% Bureau of Turnpikes Funded.

CONTINGENCY: The contingency amount is proposed to be 5% of the contract amount. This contract has the potential for unanticipated signage needs due to varying field conditions (soil and soil characteristics) which may impact sign foundation designs.

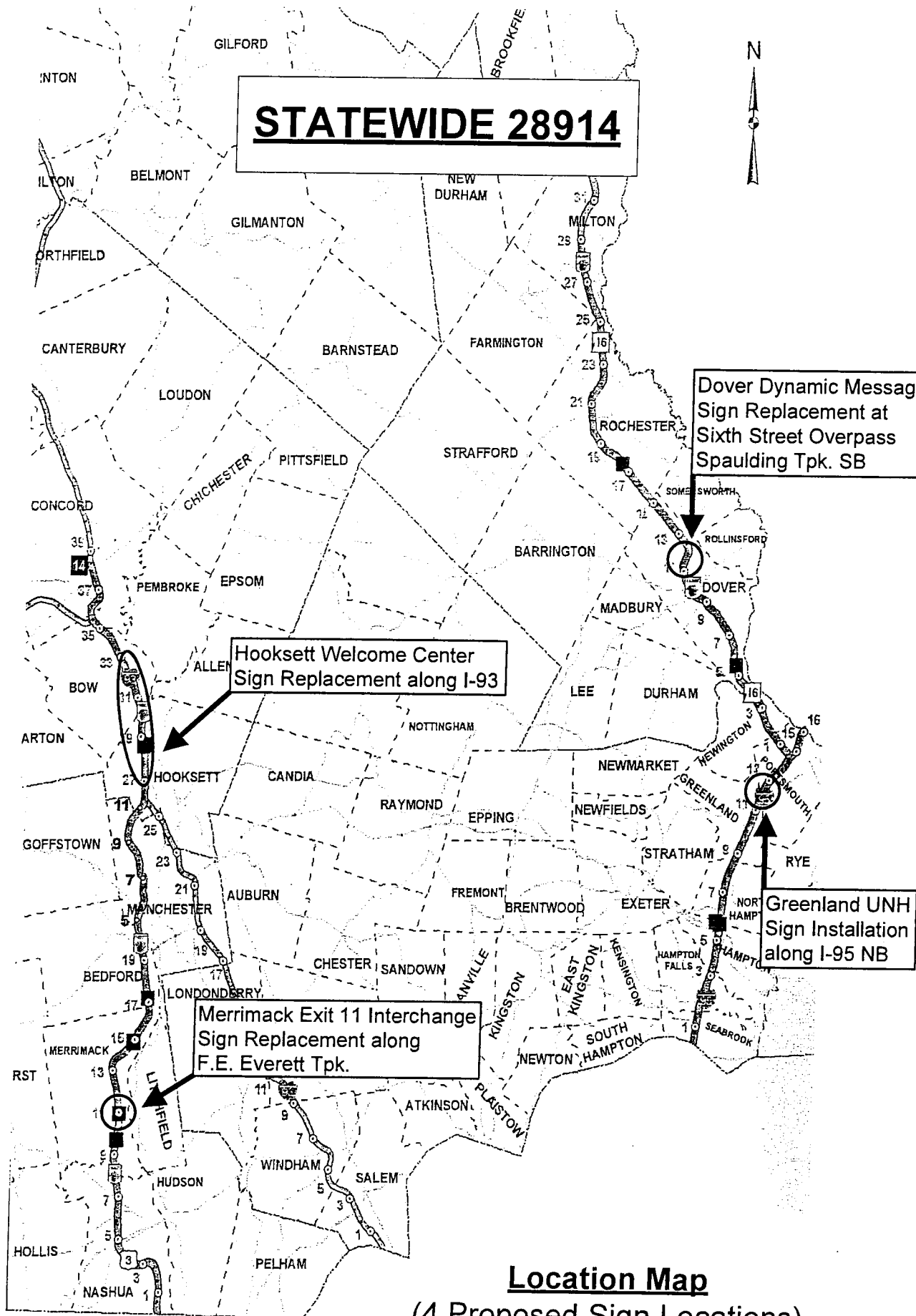
PROJECT INITIATED: Turnpikes Renewal & Replacement Program.

PROJECT EXPLANATION: The existing signage at the Exit 11 interchange in Merrimack has been in place since 1988 and does not meet retroreflectivity or MUTCD requirements. The existing Hooksett Rest Area signs will not meet the needs of the expanded and redeveloped facilities. There are no UNH guide signs along I-95 NB; signage of this nature is warranted. The existing bridge mounted dynamic message sign on the Spaulding Turnpike at Exit 6 is not functioning and repairs are as expensive as the installation of the new sign proposed. All signage included in this contract will improve awareness and safety of travelers.

TRAFFIC IMPLICATIONS: Lane closures, shoulder closures and night work are anticipated on this contract. Lane closures will be used to allow for the removal and installation of overhead signs (bridge or sign structure mounted) and will be restricted to night time operations. Shoulder closures will be permitted during daytime operations where the work is outside the traveled way. Uniformed officers will be required for both lane and shoulder closures due to the high-speed and high-volume nature of the facilities.
