### REQUESTED ACTION

- 1. Pursuant to the provisions of RSA 14:30-a, VI, Additional Revenues, authorize the Department of Health and Human Services, Division of Public Health Services, Bureau Of Infectious Disease Control, to accept and expend federal funds in the amount of \$678,574 from the US Centers for Disease Control and Prevention (CDC) to fund the New Hampshire Adult Immunization Program effective upon date of approval by the Fiscal Committee and Governor and Council, through June 30, 2017, and further authorize the funds to be allocated as follows. Grant funds awarded for periods after SFY 2017 will be included in the future operating budgets for SFY 2018 and SFY 2019. 100% Federal Funds
- 2. Pursuant to the provisions of NH RSA 124:15, Positions Restricted, and subject to the approval of item 1 above, authorize the Department of Health and Human Services, Division of Public Health Services, Bureau of Infectious Disease Control, Adult Immunization Program to establish two positions utilizing funds from the US Centers for Disease Control and Prevention, Adult Immunization Program Cooperative Agreement effective upon date of approval by the Fiscal Committee and Governor and Council, through June 30, 2017.

## **EXPLANATION**

The New Hampshire Adult Immunization Program (NHAIP) will implement interventions to improve overall adult vaccination rates through education, collaboration, and interventions to utilize Section 317 vaccine funds. Consistent with the Healthy People 2020 goals, the NHAIP will place particular focus on 1) increasing the percentage of adults aged 18 and older who are vaccinated against influenza, 2) increasing the percentage of hepatitis B vaccine coverage among high risk

populations, 3) increasing the percentage of adults who are vaccinated against pneumococcal disease, 4) increasing the percentage of adults vaccinated with Tdap vaccine and, 5) increasing the percentage of adults who are vaccinated against zoster. Through partnerships with community health centers, pharmacies, a hospital practice system and a local health department, NHAIP will, 1) increase the percentage of providers enrolled in the Adult Immunization Program for uninsured adults, 2) increase the percentage of providers routinely assessing and recommending adult vaccines, 3) increase the percentage of providers who establish health care systems interventions and referral mechanisms to improve access to vaccines, and 4) increase the number of providers who are documenting adult vaccines administered.

Funds are budgeted for Current Expenses (Class 020) for the purchase of office supplies, photocopying, printing, postage, and other consumables.

Funds are budgeted for Equipment (Class 030) for the purchase of one tablet and one desktop computer and software licenses for the newly created positions as well as an LCD projector and two new VOIP desk phones.

Funds are budgeted in Telecommunications (Class 039) for monthly VOIP expenses and conference calls to support programmatic activities.

Funds are budgeted for Audit costs (Class 041) per state requirements.

Funds are budgeted for Additional Fringe Benefits (Class 042) for post-retirement benefits.

Funds are budgeted for Temporary Full Time Personal (Class 059) to hire the two positions requested above.

Funds are budgeted for Benefits (Class 060) for benefits for the new positions.

Funds are budgeted for In-State Travel (Class 070) to cover travel expenses that staff will incur while performing their duties.

Funds are budgeted for Out-of-State Travel (Class 080) for the Adult Immunization Program staff to attend regional and national training required of the program. Conferences include the National Immunization Conference, the National Adult & Immunization Summit and a Grant Implementation Summit all anticipated taking place in Atlanta, Georgia.

Funds are budgeted for Contracts for Program Services (Class 102) to contract with local health departments for community outreach in underserved populations, to contribute towards module enhancements for the immunization information systems and to purchase and analyze aggregate adult immunization data for nine community health centers in New Hampshire. The first year baseline data will be received and assessed to determine adult immunization coverage rates. The second year data will be analyzed to determine the effectiveness of promotional and educational activities.

2) Nature, need and duration:

### Full-time Public Health Nurse Coordinator, LG 23, Position # 9T2809

Public Health Nurse Coordinator (PHNC) position is essential to assist with developing adult immunization education materials for implementation of the Standards for Adult Immunization Practice, and to conduct webinar presentations for adult vaccine providers (private practices, community health centers and pharmacies). The PHNC will reach out to adult immunization providers and establish partnerships to increase adult immunization awareness to the public and adult providers. The PHNC will be responsible to conduct site visits to adult immunization providers to provide education and technical assistance.

## Full-time Program Assistant II, LG 15, Position# 9T2807

The program assistant is essential to assist with the development of the immunization survey and to provide technical assistance for the immunization survey to the adult immunization providers. This position is essential in the Immunization Section to assist with developing and disseminating adult immunization materials, upcoming educational webinars and tracking the responses of webinar attendees. This position will assist with scheduling weekly meetings for the adult immunization team and recording minutes of the meeting. The program assistant will create email lists of the participating community health centers, hospital system practices, pharmacy and community partners who will be working with NHIS on the adult immunization agreement. The program assistant will be responsible for data entry and tracking of adult immunization information. All positions are from the date of hire until the project completion.

3) Relationship to existing agency programs:

The Cooperative agreement for Increasing Awareness and Implementation of the Standard for Adult Immunization Practices Through Partnerships with the State and Local Immunization Programs will enhance the adult immunization program's existing capabilities and complement the childhood immunization program.

- 5) Why wasn't funding included in the agency's budget request?

These funds were awarded effective September 30, 2015. It was not known that these funds would be available at the time the agency established its SFY 2016-2017 biennial budget.

6) Can portions of the grant funds be utilized for other purposes?

This request is 100% federally funded and can only be used for the purpose of the grant award.
