EXPLANATION

Initiated in the 1980's as a collaborative effort between the University of New Hampshire and the State, the GRANIT system creates, maintains, and makes available a digital geographic database to state, federal, regional, and local decision-makers and the public. GRANIT's data includes transportation data and high-resolution imagery from the NH Department of Transportation, surficial geology and aquifer data from DES, floodplain data from OEP, wildlife sightings data from NH Fish & Game, and Natural Heritage Bureau data from the NH Department of Resources and Economic Development.



Funds are requested for the following purposes:


