REQUESTED ACTION

Pursuant to RSA 261:97-c, Use of Funds, authorize the Department of Natural and Cultural Resources, State Council on the Arts to award a Conservation Number Plate (Moose Plate) Grant to the Lisbon Area Historical Society (VC #312689) Lisbon, NH in the amount of \$12,300 for the restoration of historic theater curtains effective upon Governor and Executive Council approval through June 30, 2020. 100% Other Funds Agency Income

Funding is available in account, Conservation Plate Fund, as follows:

EXPLANATION

The Conservation Number Plate Fund is used to promote the use and conservation of cultural resources in New Hampshire and to preserve the cultural heritage that belongs to all New Hampshire citizens by providing for the preservation of publicly owned historic properties.'

The Towns of Lyman and Lisbon have had a very close bond since the 1770s. Many of the two towns' settler families are connected and still live in Lyman and Lisbon. Lyman is more rural than Lisbon, and Lyman residents have always utilized Lisbon's "downtown" business district and its public services. The Lyman Grange played a major part in the social, service, and civic life of all ages of the two communities from the late 1800s into the midto-later 1900s. The Lyman Grange has been the home to three historic curtains hanging in the second-floor of the Hall. The partnership between the towns will preserve the curtains and make them available to the public.

The c.1930s "Musicians" Curtain has silhouetted musicians around a rainbow with balloons advertising 13 Lisbon businesses and one Lyman business. There is an ad for James Rowe, a well-known area cattle, horse, and farm equipment dealer in Woodsville, NH, 10 miles south of Lisbon and an ad for a jeweler in Littleton, NH., 10 miles north of Lisbon. None of the businesses exists today. The design is not typical of advertising curtains, but the idea of displaying local businesses on stage curtains was a common way for Grange and other community organizations to pay for the cost of the curtain.

The c. 1935 Street Scene has a generic street scene with signs advertising 20 Lisbon, 11 Littleton, 2 Lyman, 2 Woodsville, and one Franconia business. None of the businesses exists today. The c. 1935 Grand Drape has a generic balcony view of a lake, trees and mountains with two rows of large marble columns with billowing drapes pulled back between the columns. The three painted curtains, especially the Street Scene and Musicians Curtains are important to their local heritage. The Musicians Curtain was painted by Lucretia Rogers of Plymouth, NH. The Grand Drape and Street Scene Curtains were painted by Marion Fracher of Wentworth, NH

The conserved Street Scene Curtain and Grand Drape will remain in Lyman, installed and displayed in the Lyman Grange Hall on a long wall of the first-floor meeting/dining room which will be available to the public during annual social gatherings coordinated by the Town of Lyman and Lyman Community Group. There will be a dedicated space to display the Musicians Curtain in the new Lisbon Area Historical Society museum facility. Until that space is available, the Musicians Curtain will be displayed on a custom-made display rack in the temporary museum space in the Parker Block at 6 South Main Street, Lisbon and at public programs at the White Church, South Main St., Lisbon, NH.

The Attorney General's office has approved the agreement as to form, substance and execution.

NEW HAMPSHIRE STATE COUNCIL ON THE ARTS GRANT AGREEMENT



This agreement between the State of New Hampshire, New Hampshire State Council on the Arts (hereinafter "Council") and Lisbon Area Historical Society (hereinafter "Grantee") is to witness receipt of funds subject to the following conditions:

i. GRANT PERIOD: FY2020

2. OBLIGATIONS OF THE GRANTEE:

- The Grantee agrees to accept \$12,300.00 and apply it to the program(s) described in the grant application and
 approved budget for To support three historic painted theater curtains. In the performance of this grant
 agreement, the Grantee is in all respects an independent contractor and is neither an agent nor employee of the State.
- Funding credit including Council logo must appear in all programs, publicity, and promotional materials. The
 following wording and Council logo should be used:



Lisbon Area Historical Society is supported in part by a grant from the New Hampshire State Council on the Arts & the Mooseplate License Plate Program.

- The Grantee acknowledges that the NHSCA Program Coordinator may schedule a site visit to the organization and may request a site visit from the NHSCA.
- The Grantee agrees to abide by the limitations, conditions and procedure outlined herein and in the attached
 appendices. If appropriated funds for this grants program are reduced or terminated, all payments under this grant
 may cease. That determination rests within the sole discretion of the Council.
- 3. PAYMENT will be made following the receipt and execution of all required documents and approval of the Governor and Executive Council
- 4. FINAL REPORT: The Grantee agrees to submit a final financial and narrative report on a form provided by the Council no more than 30 days after the end of the grant period. Failure to submit the final report will render the Grantee ineligible for Council funding for two years.
- 5. **SOVEREIGN IMMUNITY:** No provision of this contract is to be deemed a waiver of sovereign immunity by the State of New Hampshire.


