## **REQUESTED ACTION**

Pursuant to RSA 94:6, the New Hampshire Department of Employment Security respectfully requests approval for Adam L. Woods, Counsel, (Position # 9U617) to be placed at a compensation level higher than the minimum established in RSA 94:1-a. This request is to place Attorney Woods' annual salary in Group FF, Step 2, \$76,606.40 (range \$71,896.24 - \$100,159.28), appropriation #010-027-8040-013, (100% Federal Funds), effective upon Governor and Council approval or August 30, 2019, whichever is later.

## **EXPLANATION**

I would like to appoint Adam Woods to the position of Counsel beginning August 30, 2019. This is an unclassified position within the Department. See Chapter 276:218, Laws of 2015: Department of Employment Security, Unemployment Insurance Fraud Prosecutor, and Position Established.

This position, which is shared with the Attorney General's Office, was created to prosecute fraud and other criminal acts perpetrated against the Department of Employment Security in order to deter the general public from engaging in such conduct and to protect the Unemployment Insurance Trust Fund. Attorney Woods possesses six (6) years of prosecution experience in the State of New Hampshire, including working with both the Cheshire and Belknap County Attorneys' Offices, most recently serving as the Deputy County Attorney for the Belknap County Attorney's Office. He is considered highly qualified in the areas needed to carry out the responsibilities of this important position. The Department's continued focus on prosecuting unemployment fraud in advance of the next economic downturn is critical, not only to bring justice to those violating the law, but also to continue our efforts to deter fraudulent behavior at even higher levels when claim volumes rise.
