EXPLANATION

The Department is requesting to (i) accept additional agency income drug rebate revenue in the Medicaid program and (ii) transfer general funds from Medicaid to the State Phase Down account.

The Department seeks to utilize additional agency income drug rebate revenue to lapse at year end to meet the Department's lapse target amount. Drug rebates are generated from the Regular Drug Rebates and the Supplemental Drug Rebates. (1) Regular Drug Rebates are received based on a Federal per unit rebate amount. (2) Supplemental Rebates are received as an "add-on" rebate based on a Preferred Drug List (PDL). As part of the Managed Care Organizations contract high costing drugs for Hepatitis C, Hemophilia, and individual drugs Carbaglu and Ravicti were carved out of MCO plans. New Hampshire is now able to bill these drugs for Supplemental Rebates which has generated higher than budgeted drug rebate revenues.

The Department requests to transfer the general funds from 79480000 Medicaid Care Management as the account contains a budget footnote *F. This appropriation shall not lapse until June 30, 2019.* The general funds are requested to be transferred to the State Phase Down 79390000 accounting unit where the general funds will lapse at state fiscal year end.

The following is the information specifically required when transfers are requested, in accordance with the Budget Officer's instructional memorandum dated April 17, 1985, to support the above requested actions:

- A. Justification: As noted above, this accept and expend request is utilizing available agency income drug rebate revenue to help satisfy the Department's state fiscal year end lapse target.
- B. Does this transfer involve continuing programs or one-time projects?

 This transfer involves the acceptance of additional agency income drug rebate and transferring the general funds surplus from 79480000 Medicaid Care Management, a non-lapsing account to the 79390000 State Phase Down which is a lapsing 100% general funded account.
- C. Is this transfer required to maintain existing program levels or will it increase the program level?

This transfer is required to lapse surplus general funds at state fiscal year end.

- D. Cite any requirements which make this program mandatory.

 The programs of the Department are mandated by various state and federal laws.
- E. Identify the source of funds on all accounts listed on this transfer. 047-7948 is 50.8% federal, 24.6% general and 24.6% other funds; 047-7939 is 100% general funds
- F. Will there be any effect on revenue if this transfer is not approved?

 Yes, the surplus funds currently reside in a non-lapsing account. If this transfer is not approved, the surplus general funds would be carried forward into state fiscal year 2019 and would not lapse.
- G. Are funds expected to lapse if this transfer is not approved?

 If this transfer is not approved, the surplus general funds would be carried forward into state fiscal year 2019 and would not lapse.
