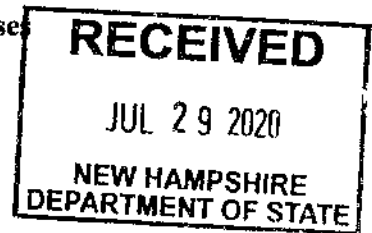



Section V
