The Program Specialist II (Integrity Task Force Coordinator) position is responsible for providing the programmatic support and technical assistance required to further the goals and objectives of NH Employment Security's UI Integrity Cross-Functional Task Force and UI Integrity Strategic Plan targeting the prevention, detection and reduction of improper Unemployment Insurance (UI) payments.

This position has been instrumental in assisting the NHES UI Integrity Section with meeting its fraud prevention and detection activities as well as continuous program improvement and reporting requirements in accordance with all state and federal laws, regulations and program guidelines.

The Integrity Task Force Coordinator's specific accountabilities include but are not limited to coordinating the activities of the NHES Cross-Functional UI Integrity Task Force, researching and analyzing performance data, tracking and maintaining metrics, preparing regular progress reports to submit to the US Department of Labor (USDOL), make recommendations for business and technical process improvements to the Assistant to the Commissioner and the UI Integrity Task Force and providing technical and administrative support to the UI Integrity Section (e.g., Quality Control Unit, Benefit Payment Control Unit) and other sections within the Department to test and implement system changes, resolve issues and address questions to facilitate the timely implementation of program changes.
