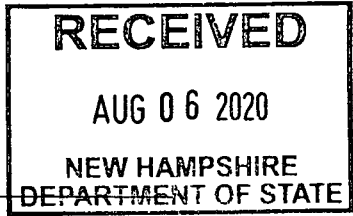



Section V
