Your Excellency and Members of the Council:

REQUESTED ACTION

Authorize the Department of Justice to accept and expend \$24,468 from the Federal Bureau of Justice Assistance, Office of Justice Programs, U.S. Department of Justice, Residential Substance Abuse Treatment Grant Program (RSAT) to be utilized to support residential substance abuse treatment efforts upon approval of the Governor and Executive Council through September 30, 2021.

Funds are to be budgeted in 02-20-20-201510-44750000, Residential Substance Abuse TRM as follows:

EXPLANATION

This request is to accept additional funds, in the amount of \$24,468, over the authorized budgeted amount.

RSAT is a federal formula grant utilized for the sole purpose of assisting states and units of local government to establish and maintain residential substance abuse treatment programs in correctional and detention facilities where adult and juvenile offenders are incarcerated for a sufficient period of time to permit substance abuse treatment. This program also provides aftercare and supervision for high risk offenders who are at risk of reoffending due to drug abuse issues.

The majority of programs sustained through this grant are as follows:

- Strafford County: Segregated therapeutic communities for men and women.
- Grafton County: Specialized programming for women.
- NH Department of Corrections: Family unification programming as part of a larger substance use disorder treatment program.
- Sullivan County: Transitional Reentry and Inmate Life Skills (TRAILS) program that has been replicated statewide.
- Merrimack County: Community Corrections Program which supports substance abuse offenders through release and integrates them back into the community.

The recipients must collect and maintain data that measure the performance and effectiveness of work under the award. The data must be provided to the Office of Justice Programs (OJP) in a manner and within the timeframe specified by OJP in the program solicitation or other applicable written guidance.

In the event that federal funds become no longer available, general funds will not be requested to support this program.

1. Requirements of the award; remedies for non-compliance or for materially false statements

7. Requirement to report potentially duplicative funding

16. Effect of failure to address audit issues

21. Restrictions on "lobbying"

In general, as a matter of federal law, federal funds awarded by OJP may not be used by the recipient, or any subrecipient ("subgrantee") at any tier, either directly or indirectly, to support or oppose the enactment, repeal, modification, or adoption of any law, regulation, or policy, at any level of government. 24. Restrictions and certifications regarding non-disclosure agreements and related matters

25. Compliance with 41 U.S.C. 4712 (including prohibitions on reprisal; notice to employees)

Subject: Categorical Exclusion for New Hampshire Department of Justice

The Residential Substance Abuse Treatment (RSAT) Formula Grant Program provides funds to the states, territories, and the District of Columbia for use by the state and units of local government in developing and implementing residential substance abuse treatment programs within correctional and detention facilities in which prisoners are incarcerated for a period of time sufficient to permit substance abuse treatment.

None of the following activities will be conducted whether under the Office of Justice Programs federal action or a related third party action:

- (1) New construction.
- (2) Any renovation or remodeling of a property located in an environmentally or historically sensitive area, including property (a) listed on or eligible for listing on the National Register of Historic Places, or (b) located within a 100-year flood plain, a wetland, or habitat for an endangered species.
- (3) A renovation that will change the basic prior use of a facility or significantly change its size.
- (4) Research and technology whose anticipated and future application could be expected to have an effect on the environment.
- (5) Implementation of a program involving the use of chemicals.

Additionally, the proposed action is neither a phase nor a segment of a project that when reviewed in its entirety would not meet the criteria for a categorical exclusion.

Consequently, the subject federal action meets the Office of Justice Programs' criteria for a categorical exclusion as contained in paragraph 4(b) of Appendix D to Part 61 of Title 28 of the Code of Federal Regulations.
