

**RECEIPTS AND EXPENDITURES – RSA 664:6**  
**Special Election – Merrimack District 24**

**664:7 Reporting by Candidates.** Each candidate at the primary or general election for representative to the general court who has expenditures exceeding \$500 shall file statements before and after an election in like manner and detail as for political committees.

**664:6, I Reporting by Political Committee.** Any political committee whose receipts or expenditures exceed \$500 shall file with the secretary of state an itemized statement in the form prescribed by the secretary of state, signed by its chairman and treasurer showing each of its receipts exceeding \$25 with the full name and postal address of the contributor in alphabetical order and the amount of the contribution, the date it was received, and the aggregate total for each election for each contributor of over \$100. All receipts of \$25 or under shall appear on the statements as unitemized receipts. Any listing that exceeds an individual's aggregate total of \$100 for each election shall be accompanied by the contributor's occupation including official job title, the name of the contributor's employer, and the city or town of the contributor's principal place of business, if any. The statement shall also show each committee expenditure exceeding \$25 with the full name and postal address of the payee or promise of payment, the date paid or obligated, and the election for which the expenditure was made, with the specific nature and amount of each expenditure since the date of registration.

***Filing Dates for Special Primary Election – January 21, 2020***

**January 2, 2020** – report to summarize and itemize all receipts and expenditures through December 30th

**January 15, 2020** – report to summarize any previous reports and itemize additional receipts and expenditures through January 13th. In addition to this reporting requirement, the secretary of state shall be notified by the fiscal agent within 48 hours of any contribution exceeding \$500 which is received after the statement due January 15th and prior to the day of the primary election.

**January 29, 2020** – report to summarize any previous reports and itemize all other receipts and expenditures through the date of the special primary election (January 21, 2020).

***Filing Dates for Special Election – March 10, 2020***

**February 19, 2020**– report to cover receipts and expenditures since primary election through February 17th.

**March 4, 2020** – report to summarize any previous reports from special election and itemize additional receipts and expenditures through March 2nd. In addition to this reporting requirement, the secretary of state shall be notified by the fiscal agent within 48 hours of any contribution exceeding \$500 which is received after the statement due March 4 and prior to the day of the special election.

**March 18, 2020** – report to summarize any previous reports from special election and itemize all other receipts and expenditures through date of special election (March 10, 2020)

**September 18, 2020**– Any candidate or committee with any outstanding debt, obligation, or surplus following the special election shall file reports at least once every 6 months thereafter until the obligation or indebtedness is entirely satisfied or surplus deleted, at which time a final report shall be made.

**NOTE:** Any candidate or committee whose expenditures do not exceed \$500 for a reporting period need not file for that reporting period. However, once the accumulated expenditures for a candidate exceed \$500, then a statement shall be filed at the next reporting deadline, and the candidate shall continue to file at each subsequent reporting deadline.
