REQUESTED ACTION

That approval be and hereby is given to the Attorney General to reappoint K. Allen Brooks (Position #9U042, Appropriation #02-20-200510-2613-013-500132) as an Assistant Attorney General, at a salary level of \$95,344.22 effective upon Governor and Executive Council approval or July 5, 2019, whichever is the latter. EXPLANATION

Mr. Brooks is a resident of Hopkinton and is a member of the New Hampshire Bar. He received his law degree from Southern Illinois University School of Law in 1999. Prior to joining the Department, he worked as a Coastal Program Analyst with the State of California, San Francisco Bay Conservation and Development Commission from 2000 to 2004. Mr. Brooks joined the Department in the Environmental Protection Bureau in 2004 and was appointed an Assistant Attorney General in October, 2004. He was appointed as a Senior Assistant Attorney General and the Environmental Protection Bureau Chief in October, 2008. I plan to continue his assignment in the Environmental Protection Bureau. His salary as a Senior Assistant Attorney General is \$95,344.22 and will remain the same. A copy of his resume is attached.
