REQUESTED ACTION

That approval be and hereby is given to the Attorney General to appoint Diane M. Quinlan as the Director of Charitable Trusts (Position #9U258, appropriation #02-20-201010-2621-013-500132) and as an Assistant Attorney General at a salary of \$104,000, effective upon Governor and Executive Council approval or June 3, 2022, whichever is later, for a term ending March 22, 2024.

EXPLANATION

Ms. Quinlan, a Merrimack resident, earned her Bachelor of Arts from the College of the Holy Cross in 1984 and her Juris Doctor, *cum laude*, from Suffolk University Law School in 1990. Following law school graduation, she clerked for the Hon. Martin F. Loughlin at the U.S. District Court for the District of New Hampshire from 1990 to 1991. She then practiced as an Associate at Conley, Haley, O'Neil and Kaplan in Bath, Maine from 1991 to 1992, and at Rath, Young, Pignatelli and Oyer in Concord from 1992 to 1995. She was a Shareholder and Officer at Devine, Millimet and Branch in Manchester from 1995 to 2002. Ms. Quinlan left private practice in 2002 to become Vice Chancellor and General Counsel for the Diocese of Manchester. She was promoted to Chancellor and General Counsel in 2004, which position she held until 2019. She joined the Department of Justice as Assistant Director of the Charitable Trust Unit in August 2019 and has served in that capacity since that date. In light of Ms. Quinlan's varied and extensive legal experience, I would like to appoint her as the Director of Charitable Trusts at a salary of \$104,000, for a term ending March 22, 2024. A copy of her resume is attached.
