REQUESTED ACTION

Pursuant to RSA 261:97-c, <u>Use of Funds</u>, authorize the Department of Natural and Cultural Resources, State Council on the Arts to award a Conservation Number Plate (Moose Plate) Grant to the Portsmouth Historical Society (VC#154242), Portsmouth, NH in the amount of \$20,000 for the renovation of accessible restrooms effective upon Governor and Executive Council approval through June 30, 2020. 100% Other Funds (Agency Income)

Funding is available in account, Conservation Plate Fund, as follows:

EXPLANATION

The Conservation Number Plate Fund is used to promote the use and conservation of cultural resources in New Hampshire and to preserve the cultural heritage that belongs to all New Hampshire citizens by providing for the preservation of publicly owned historic properties.

The Portsmouth Historical Society's vision of a mixed use space—to be known as Discover Portsmouth—incorporated a Welcome Center, public restrooms, meeting space, substantial exhibition galleries featuring displays of regional arts and culture. Last year, 40,000 people went through the doors of Discover Portsmouth to see their museum exhibitions displayed in three gallery spaces; purchase items from the museum shop; attend lectures, school education programs, social events and other activities.

Discover Portsmouth is also considered to be the City of Portsmouth's official Welcome Center where visitors come to learn about Portsmouth's history, receive materials about the cultural and historic sites around town, and use the only public restrooms in downtown. It is unacceptable that this site, the first stop on many visitors' outings to the City, does not accommodate all guests with accessible, up-to-date bathroom facilities. New bathrooms can only enhance the functions of Discover Portsmouth and make the cultural programming accessible to all patrons.

The Attorney General's office has approved the agreement as to form, substance and execution.

2. OBLIGATIONS OF THE GRANTEE:

- The Grantee agrees to accept \$20,000.00 and apply it to the program(s) described in the grant application and approved budget for To support the renovation of the public restrooms for accessibility. In the performance of this grant agreement, the Grantee is in all respects an independent contractor and is neither an agent nor employee of the State.
- Funding credit including Council logo must appear in all programs, publicity, and promotional materials. The

- The Grantee acknowledges that the NHSCA Program Coordinator may schedule a site visit to the organization and may request a site visit from the NHSCA.
- The Grantee agrees to abide by the limitations, conditions and procedure outlined herein and in the attached appendices. If appropriated funds for this grants program are reduced or terminated, all payments under this grant may cease. That determination rests within the sole discretion of the Council.
- 3. PAYMENT will be made following the receipt and execution of all required documents and approval of the Governor and Executive Council
- 4. FINAL REPORT: The Grantee agrees to submit a final financial and narrative report on a form provided by the Council no more than 30 days after the end of the grant period. Failure to submit the final report will render the Grantee ineligible for Council funding for two years.
- 5. **SOVEREIGN IMMUNITY**: No provision of this contract is to be deemed a waiver of sovereign immunity by the State of New Hampshire.










Michaela Neiro

Chief executive officer of a venerable historical institution that is the governing authority for the Old State House Museum, for the Boston History Research Library and Archive, and for Revolutionary Boston Programs

- Turned around a venerable 130-year-old institution in a serious organizational and financial crisis; after
 making judicious cuts, reorganizing operations, and developing a new mission vision, I balanced the
 budget during each of the following dozen years, doubled its annual operating funding, increased its FTE
 staff by 100%, tripled its financial reserves, and increased visitation by more than a third
- Oversaw all internal operations for three entities and their departments, including: Public History;
 Education and Exhibitions; Marketing and Commercial Operations; Finance and Administration;
 Development and Communications; and Facilities and Historic Preservation. Structured staffing, planned facilities projects, prepared and monitored adherence to annual budgets, and ensured that the resources were obtained to support essential functions
- Raised \$7 million for the restoration, reinterpretation, and maintenance of Boston's Old State House, a nationally-important landmark, and the oldest surviving public building from British colonial America

 revenues founfold
