REQUESTED ACTION

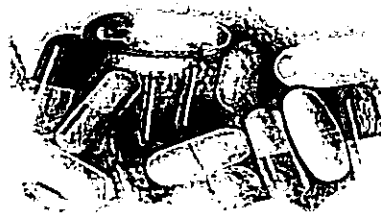
