

REQUESTED ACTION

1. Authorize the Department of Transportation to enter into a contract with Pike Industries, Inc. (Vendor 177300) of Belmont, NH on the basis of a low bid of \$2,018,395.50 for resurfacing two segments on I-89 in the towns of Sutton and New London, from the date of Governor and Council approval through August 9, 2019 unless extended by the Department in accordance with the Standard Specifications. 100% Federal Funds.

Funding is available in State Fiscal Year 2019 and is contingent upon the availability and continued appropriation of funds in Fiscal Year 2020 as follows, with the ability to adjust encumbrances through the Budget Office between State Fiscal Years if needed and justified:

2. Further authorize that a contingency in the amount of \$100,919.77 be approved for payment of latent conditions, which may appear during the construction of the project. The contingency requested is 5% of the contract amount.

EXPLANATION

This project is part of the State's Ten Year Transportation Improvement under the Tier 1 Pavement Preservation Program. This contract includes the resurfacing of two segments of I-89 in the towns of Sutton and New London. The treatment on the mainline will be a Bonded Wearing Course (BWC) overlay within the travel way and a fog seal on the shoulders. Bridges will receive a 1" BWC inlay. Ramps will receive a 1 ½ inch HBP inlay.

The overall pavement condition in each section is fair. These sections have sustained a rutting rating of fair which is the primary factor for this treatment. The segment in New London was last rehabilitated in 2010 with a 2" binder inlay of the travel way (full width at bridges) and a 1" full width wearing course overlay. The segment in Sutton was last reconstructed in 2006 with 24 inches of sand, 12 inches of

gravel, 12-15½ inches of crushed gravel, and 6½ inches of HBP. This preservation project will address and fix the issues to extend the life of the pavement.

The contingency amount is proposed to be 5%. This is due to no survey being performed for this project resulting in a higher uncertainty of the accuracies of pavement measurements.

The Contractor has been prequalified by this Department. The Contract has been approved by the Attorney General as to form and execution, and the Department has certified that the necessary funds are available and the bid reasonably conforms to the engineer's estimate in accordance with State procedure. Copies of the fully executed contract are on file at the Secretary of State's Office and the Department of Administrative Service's Office, and subsequent to Governor and Council approval will be on file at the Department of Transportation.

Project funding for 41219 is 80% federal funds with 20% state match. Turnpike toll credit is being utilized for match requirements, effectively using 100% federal funds. Project funding for 41061 is 90% federal funds with 10% state match. Turnpike toll credit is being utilized for match requirements, effectively using 100% federal funds.

A copy of the Tabulation of Bids received for this project is attached along with the Contract Supplemental Sheet and a map indicating the location of the project.

DESCRIPTION: This contract includes the resurfacing of two segments of I-89 in the towns of Sutton and New London. The treatment on the mainline will be a Bonded Wearing Course (BWC) overlay within the travel way and a fog seal on the shoulders. Bridges will receive a 1" BWC inlay. Ramps will receive a 1 1/2 inch HBP inlay.

PROJECT INITIATED: State's 10-Year Transportation Improvement Plan

PROJECT EXPLANATION: The overall pavement condition in each section is fair. These sections have sustained a rutting rating of fair which is the primary factor for this treatment. The segment in New London was last rehabilitated in 2010 with a 2" binder inlay of the travel way (full width at bridges) and a 1" full width wearing course overlay. The segment in Sutton was last reconstructed in 2006 with 24 inches of sand, 12 inches of gravel, 12-151/2 inches of crushed gravel, and 61/2 inches of HBP. This preservation project will address and fix the issues to extend the life of the pavement.


TRAFFIC IMPLICATIONS: As I-89 is a two lane facility, one lane will be closed at a time for construction activities. A 16-foot minimum lane width will be provided at all times when using one-lane traffic on I-89. Ramp work in the areas of Exit 11 and 12, will require all 8 ramps to be closed individually at night with signed detours in place. Work Zone Significance determined to be Non-Significant on June 21, 2018.




