REQUESTED ACTION

The Department of Transportation requests approval of Governor and Council to pay small claims under the provisions of RSA 228:29 for the next fiscal year, July 1, 2022 through June 30, 2023. At the conclusion of the State fiscal year, the Department will submit a report identifying the small claims activity.

EXPLANATION

RSA 228:29 authorizes the Commissioner to use funds accruing to the Department of Transportation for the payment of small claims occasioned by accidents due to the activities of the Department of Transportation. Any person claiming damage due to the activities of the Department of Transportation may seek payment of the small claim if the amount is less than \$2,000.00 for FY 2023. If, upon investigation, the small claim is valid, the Commissioner shall submit the recommendation for payment to the Governor and Council for approval.

To improve efficiency in processing these small claims, and to be more responsive to those claimants' awaiting payment for a small claim, the Department of Transportation initiated a blanket approval process at the beginning of Fiscal Year 1996. The revised process was approved by Governor and Council on July 19, 1995 as Item #171 (see attached). The process requires the Department of Transportation to seek approval from Governor and Council prior to each Fiscal Year and to submit the claims paid in the previous Fiscal Year.

Each claim is investigated and thoroughly reviewed before approval (or denial) by the Assistant Commissioner. The investigations can take time and when a decision is reached, claimants are often anxious to receive timely compensation. To date, 47 claim approval requests have been submitted to Governor and Council for reimbursement necessitating multiple requests to G&C. The average claim for FY22 was \$835.07, well below the G&C threshold. The annual reporting affords the Council an overall summary of the claim activity and provides transparency. This process has proven to be a long time efficient and practical means of administering these small claims.

Re: Blanket Approval to Pay Small Claims

REQUESTED RESOLUTION

Resolved that the Commissioner of the Department of Transportation, or his designee be authorized to pay Small Claims submitted under the provisions of RSA 228:29 for the period of August and September 1995.

EXPLANATION

Small claims submitted to the Department in an amount of less than \$600.00 may be investigated by the Commissioner for payment thereof. At the conclusion of the investigation, if the Commissioner is of the opinion that the damage was caused because of activities of the Department, he submits his recommendation to the Governor and Council for approval.

Past practice has had individual claims submitted for approval on a one to one basis for amounts as low as \$50.00. Beginning in October, 1995 blanket approvals will be requested on a quarterly basis. At the conclusion of each blanket period an activities report will be supplied. The grouping of claims submitted on a quarterly basis would expedite the payment of claims, and reduce the amount of Department requests for approval to the Governor and Executive Council.

Your approval of this resolution is respectfully requested.
