



Recent federal actions have reignited debate over whether civil asset forfeiture is an effective crime fighting tool or a violation of constitutional rights. Eighty seven percent of forfeitures were civil between 1997 and 2013, meaning they were executed without a criminal conviction. State laws continue to increase the oversight, financial regulation and accountability of civil forfeiture practices by state, local and federal agencies.






