Pursuant to RSA 230:14, attached hereto is a Petition for a hearing on the proposed improvements to NH Route 123A in the Town of Acworth.

Since the Petition is not for the limitation or control of access, a Commission should be appointed to hold a hearing, and, if the necessity is found, to layout the new highway at this location.

The purpose of the project is to replace the bridge carrying NH Route 123A over Bowers Brook, (NH Bridge #113/064 and #13 on NH's 2013 Bridge Priority List). The proposed improvements will also include the reconstruction of NH Route 123A extending three hundred (300') feet east and three hundred (300') feet west of the bridge. This project may impact historic resources.
