### REQUESTED ACTION

That approval be and hereby is given to the Attorney General to appoint Benjamin W. Maki, Position # 9U537 (Appropriation # 02-20-201510-5065-013-500132), as an Assistant Attorney General, at a salary level of \$73,000, effective upon Governor and Executive Council approval or December 20, 2019, whichever is later.

#### **EXPLANATION**

Mr. Maki is a resident of Peterborough, and a member of the New Hampshire Bar. He received his law degree, cum laude, from Suffolk University Law School in 2010, and his Bachelor of Arts, magna cum laude, from Franklin Pierce College in 2006. He was the prosecuting attorney for the Wilton Police Department from March 2011 through May 2015, and was a regional prosecutor for the Cheshire County Attorney's Office from May 2015 through October 2018. He joined the Department of Justice as the Traffic Safety Resource Prosecutor in the Criminal Bureau on October 15, 2018. In view of Mr. Maki's experience, I am requesting he be appointed as an Assistant Attorney General. In light of this designation, his salary will increase by \$3,000, from \$70,000 to \$73,000. Because this position is based on an annual grant, the term for the position is at the will of the Attorney General. I plan to continue his assignment as the Traffic Safety Resource Prosecutor in the Criminal Bureau. A copy of his resume is attached.

2001 Laws of NH Chapter 158 amended RSA 94:1-a(I)(c)(3) to provide that designation of positions, salary levels, and salary increases for attorneys at the Department of Justice shall be determined by the Attorney General, subject to approval of the Governor and Council, within appropriations made to the Department of Justice.
