REQUESTED ACTION

Authorize the Department of Justice to accept and expend \$64,366, from the Federal Children's Justice Act (CJA) Grant awarded by Federal Administration for Children and Families, to support efforts to prevent child abuse and neglect effective upon the approval of the Governor and Executive Council through September 30, 2022.

These additional funds will be subgranted to organizations focused on investigations, prosecutions and prevention programs related to issues of child abuse and neglect.


Examples of programs sustained through this grant are as follows:

- Developing and conducting training for personnel in law enforcement and child protective services, as well as health and mental health professionals, prosecutors and judges.
- Enhancing or developing programs to serve child victims and their families in order to minimize trauma.
- Working with local and/or State child fatality review teams, to include multidisciplinary training, team development, and annual reporting.
