REQUESTED ACTION

1. Authorize the Department of Transportation to enter into a contract with Continental Paving, Inc. (Vendor 155350) of Londonderry, NH on the basis of a low bid of \$2,520,917.50 for resurfacing approximately 5.2 miles of US 202/4 and NH 9 from the I-393 interchange to the Epsom Traffic Circle/NH 28, from the date of Governor and Council approval through June 23, 2017 unless extended by the Department in accordance with the Standard Specifications. 100% Federal Funds.

2. Further authorize that a contingency in the amount of \$126,045.88 be approved for payment of latent conditions, which may appear during the construction of the project. The contingency requested is 5% of the contract amount.

EXPLANATION

This project is part of the State's Ten Year Transportation Improvement Plan, under the Programmatic Pavement Resurfacing/Rehabilitation & Crack Seal Program (PRRCS). This project involves resurfacing approximately 5.2 miles of US 202/4 and NH 9 from the I-393 interchange to the Epsom Traffic Circle / NH 28. Pavement work involves spot 2-inch travel way inlays and a 1½-inch full-width overlay. Other work includes guardrail resetting and replacement; removing a cantilevered sign structure and the associated guardrail run; ledge work at two (2) locations; minor improvements to three (3) drainage culverts on the east end of the project; resetting drainage structure frames, grates, and covers within the pavement; replacing sidewalk ramps and detectable warning devices at the Main Street

and Horse Corner Road intersection; and constructing a 4-foot shoulder widening near Mason Brook to accommodate the Epsom Fire Department. This project will also incorporate lane reconfiguration near the King Road intersection to provide an eastbound left turn lane for King Road and a two-way left turn lane from King Road to the Main Street and Horse Corner Road intersection. This project is part of the annual Federal Resurfacing Program and its primary focus is to rehabilitate the existing pavement to keep this section of US 202/4 and NH 9 in preservation mode.


The contingency amount is proposed to be 5% of the contract amount. The majority of the project was not surveyed and therefore, items have been quantified based on field observations, as-built plans, and aerial photos only. Field adjustments may be required (for drainage work, excavation/embankment, limits of pavement inlay work, etc.) due to varying field conditions.

The Contractor has been prequalified by this Department. The Contract has been approved by the Attorney General as to form and execution, and the Department has certified that the necessary funds are available and that the bid reasonably conforms to the engineer's estimate in accordance with State procedure. Copies of the fully executed contract are on file at the Secretary of State's Office and the Department of Administrative Service's Office, and subsequent to Governor and Council approval will be on file at the Department of Transportation.

This project funding is 80% federal funds with 20% state match. Turnpike toll credit is being utilized for match requirements, effectively using 100% federal funds.

A copy of the Tabulation of Bids received for this project is attached along with the Contract Supplemental Sheet and a map indicating the location of the project.

SUPPLEMENTAL PROJECT INFORMATION SHEET

DESCRIPTION: This project involves resurfacing approximately 5.2 miles of US 202/4 and NH 9 from the I-393 interchange to the Epsom Traffic Circle / NH 28. Pavement work involves spot 2-inch travel way inlays and a 1½-inch full-width overlay. Other work includes guardrail resetting and replacement; removing a cantilevered sign structure and the associated guardrail run; ledge work at two (2) locations; minor improvements to three (3) drainage culverts on the east end of the project; resetting drainage structure frames, grates, and covers within the pavement; replacing sidewalk ramps and detectable warning devices at the Main Street and Horse Corner Road intersection; and constructing a 4-foot shoulder widening near Mason Brook to accommodate the Epsom Fire Department. This project will also incorporate lane reconfiguration near the King Road intersection to provide an eastbound left turn lane for King Road and a two-way left turn lane from King Road to the Main Street and Horse Corner Road intersection.

FEDERAL FUNDING: 80% Federal (PRRCS); 20% State (TTC)


CONTINGENCY: The contingency amount is proposed to be 5% of the contract amount. The majority of the project was not surveyed and therefore, items have been quantified based on field observations, as-built plans, and aerial photos only. Field adjustments may be required (for drainage work, excavation/embankment, limits of pavement inlay work, etc.) due to varying field conditions.

PROJECT INITIATED: State's Ten Year Plan – Programmatic Pavement Resurfacing/Rehabilitation & Crack Seal (PRRCS)

PROJECT EXPLANATION: This project is part of the annual Federal Resurfacing Program and its primary focus is to rehabilitate the existing pavement to keep this section of US 202/4 and NH 9 in preservation mode.

TRAFFIC IMPLICATION: Existing traffic patterns or two lanes of traffic on US 202/4 and NH 9 will be maintained whenever possible. Paving work will be completed between the hours of 6 PM to 7 AM at the following locations: (1) from I-393 to the start of the eastbound truck lane, (2) through the Main Street and Horse Corner Road intersection, and (3) from Brimstone Hill Road to the Epsom Traffic Circle. Short-term, one lane, two-way traffic will be allowed from 6 PM to 7 AM. Lane closures will not be allowed during peak hours from 7 AM to 9 AM and 3 PM to 6 PM (Monday through Saturday) for construction operations from I-393 through the Main Street and Horse Corner Road intersection. Accommodations will be made for pedestrian traffic during the installation of sidewalk ramps and detectable warning devices at the Main Street and Horse Corner Road intersection.






