EXPLANATION

These courses, Leading in an Organization and Accounting & Financial Analysis will benefit the Department and the employee by furthering Mr. Madden's skill and expertise in matters of advanced management functions, processes, and skills. Leading in an Organization focuses on the study of the interactions between individuals and groups. Theories of motivation, communication, leadership, power, and change will be discussed as they relate to contemporary issues. In learning more regarding socialization and subcultures, and how to apply sociological methods of observation and interviewing he will be better able to understand and communicate more efficiently and effectively with coworkers, families, and the youth he serves. Accounting and Financial Analysis focuses on analyzing and interpreting financial statements. Understanding financial statements and being capable of analyzing them will allow him to pass the information along to the families and young adults with which he works in an effort to guide them toward self-sufficiency. This knowledge will also allow him to better understand the collection of restitution payments. Information learned will also be shared with others in his office so all can benefit.

Montana Madden has been employed by the Department of Health and Human Services, Division of Children, Youth, and Families (DCYF) for six (6) years as a Juvenile Probation and Parole Officer (JPPO). The employee's daily responsibilities include interactions with families, attorneys, police departments, and other professionals, often with individuals in distressed states. The job also requires attending hearings, conducting investigations, making recommendations and reporting to the courts as well as participating in community based and statewide committees in order to establish strong, effective working relationships with all involved in the juveniles' cases.

The Department of Health and Human Services (DHHS) encourages and supports employees who wish to further their professional growth through continuing education in disciplines that are mutually advantageous. Successful completion of these courses will add to the overall strength of the Department to perform its mission to the residents of the State of New Hampshire.

This course will not be taken on State time.

THE STATE OF NEW HAMPSHIRE EDUCATIONAL TUITION AGREEMENT

Agreement dated this <u>30 day</u> of <u>July 2019</u> by and through the Department of Health and Human Services (hereinafter referred to as the "State) and <u>Montana Madden</u> (hereinafter referred to as the "Recipient"). The **State** and the **Recipient** do hereby mutually agree as follows:

- 1. The State shall pay to the named institution the sum of \$3000.00, which monies shall be used for the purpose of enrolling the Recipient in: Leading in an Organization, Acct & Financial Analysis (course name), which course(s) is being offered by Southern New Hampshire University and which course(s) shall commence on October 28 2019 and terminate on March 29, 2020.
- 2. The Recipient shall complete and achieve a passing grade in each course named in paragraph 1.
- 3. Should the Recipient fail to complete or achieve a passing grade in each course named in paragraph 1, the Recipient shall pay to the State the sum set forth in paragraph 1, provided, however, that if more than one course is named in paragraph 1, the amount which shall be paid to the State shall be calculated on a pro rata basis.
- 4. Upon the satisfactory completion of the courses named in paragraph 1, the Recipient shall continue in the employ of the State in his/her current position (or in such other position, at equal or greater compensation, to which he/she may be assigned) for a period of six (6) months.
- 5. The Recipient shall work in any area of the State to which he/she may be assigned, provided that such assignment will not constitute a severe hardship to said Recipient.
- 6. Should the Recipient breach any of the conditions set forth in paragraphs 4 and 5, the Recipient shall pay to the State a sum equal to all monies previously paid by the State for the Recipient pursuant to the Agreement, provided, however, that the Recipient shall receive a credit for each month in which he/she is employed by the State subsequent to the date upon which the named course(s) are satisfactorily completed, the value of said credit to be calculated on a pro rata basis.
- 7. The Recipient shall not raise any setoff or counterclaim against the State in any action brought by the State to collect any amount due under this agreement.
- 8. Should any amount be found to be due the State in any action brought against the Recipient pursuant to this Agreement, the State shall, in addition to said amount, be entitled to an award of costs and a reasonable amount in "attorney" fees.
