## **EXPLANATION**

DolT previously entered into contract with Red River LLC for Cisco networking products to replace end of life (EOL) core network infrastructure, agency network equipment and to address capacity constraints along with security and compliance related issues. In partnership with Red River and Cisco, DolT's Network Optimization effort will enhance the network security posture and modernize our approach to delivering key connectivity services to our Agency customers.

In support of that effort, DoIT is requesting the transfer of appropriation from Class 038 Technology-Software and Class 039 Telecommunications to Class 037 Technology-Hardware to fund much needed copper and fiber cabling upgrades that will prepare DOT buildings for this statewide optimization project.

The funds will be budgeted as follows:

Class 038 Technology-Software: Funding is available due to planned purchases that are no longer needed or expenditures that were less than budgeted.

Class 039-Telecommunications: Funding is available due to planned purchases that are no longer needed.

Class 037- Technology-Hardware: Funding is needed for building wiring upgrades required for and/or identified by the eNHance project.
