REQUESTED ACTION

Pursuant to RSA 21-I:80, I (b), authorize the Department of Natural and Cultural Resources, Division of Parks and Recreation (Division) to make a **RETROACTIVE** and **SOLE SOURCE** payment to Lee T. Corrigan, LLC (VC #163331), Gorham, NH, in the amount of \$49,375 for emergency repairs to three (3) concrete stairwells damaged by coastal storms at North Beach in Hampton, NH, per invoice dated July 29, 2018. This damage was recently declared under FEMA Disaster DR-4370-NH. **100% Agency Income**





EXPLANATION

Three of the concrete stairways which provide public access to North Beach were severely damaged in a series of winter storms in which the concrete was battered by large cobbles. Once the stairwells were dug out from under the cobbles, it became apparent that the stairs were impassible and had to be closed to the public. This left no public access to the southern end of the beach for a half a mile. Because North Beach gets intensive use during the summer months, the Division hired Lee Corrigan, LLC on an emergency basis. Lee Corrigan, LLC had just recently finished a bid contract for the Division in the North County where they'd demonstrated their ability to perform high quality concrete work. They were also available on short notice to perform the work before the Fourth of July. For these reasons, retroactive and sole source approval is being sought.
