Explanation

The Department of Safety, Division of State Police, requests authorization to transfer funds to maintain service levels in the Traffic Bureau as detailed below.

Traffic Bureau (4003)

- Class 023, Heat, Electricity, Water \$5,000 is needed to cover utilities through the remainder of SFY 2020.
- Class 080, Out-of-State Travel \$5,000.00 is available due to the current condition that have led to restrictions on travel
 and training.

The following information is provided in accordance with the Budget Officer's instructional memorandum dated April 17, 1985 to support the above requested actions:
