REQUESTED ACTION

Pursuant to RSA 14:30-a, VI, authorize the Department of Justice to accept and expend a grant in the amount of \$493,000 from the US Department of Justice, Office of Justice Programs, Bureau of Justice Assistance, New Hampshire 2019 Statewide Drug Court Project, for the purpose of providing a strategic and targeted training program to address specific needs of adult drug courts, from the date of the Fiscal Committee of the General Court and Governor and Executive Council approvals through June 30, 2021. 100% Federal Funds.

EXPLANATION

The New Hampshire Department of Justice is seeking approval to accept and expend a grant award, received from the Federal Bureau of Justice Assistance, under the New Hampshire 2019 Statewide Drug Court Project. These funds were not previously budgeted because the grants were awarded on a competitive basis with no guarantee that New Hampshire would receive an award.

The purpose of the New Hampshire 2019 Statewide Drug Court Project Grant is to support strategies and trainings to enhance drug court practices, monitor and evaluate the drug court program, and sustain partnerships with other drug courts throughout the State. These initiatives will be performed through a partnership between the John Snow, Inc. and the New Hampshire Drug Abuse and Drug Abuse Counselors' Association. The funds will be subgranted to JSI.

The effectiveness of this grant will be measured through self-assessment surveys and staff evaluations. Drug court participant data will also be collected and analyzed based on criteria such as attendance, graduation rates and whether violations of the program have increased or decreased.

Federal award funds are budgeted to support grant activities as follows:

072-509073-Federal Grant to be subgranted to the John Snow, Inc. to provide resources and training to the New Hampshire Drug Abuse and Drug Abuse Counselors' Association.

In the event federal funds become no longer available, general funds will not be requested to support this program.

1. Requirements of the award; remedies for non-compliance or for materially false statements

The conditions of this award are material requirements of the award. 38.
