EXPLANATION

The Department requests authorization to transfer budgeted account funds among the various Accounting Units and classes in order to continue to meet the State's transportation demands.

Specific explanations relating to the Department's other spending requests are as follows:

Mechanical Services (3005) 2.53% Intra-Agency Transfers, 1.56% 007 Agency Income, 1.84% 009 Agency Income, 1.18% Agency Indirect Cost Recovery and 92.89% Highway Funds

- Class 023 Increase Heat-Electricity-Water by \$5,000. The transfer is needed due to the increased costs associated with heating oil and electricity during FY2022.
- Class 039 Decrease Telecommunications by \$1,000. Expenses in this class have been lower than anticipated during FY2022.
- Class 050 Increase Personal Service Temp Appoint by \$1,000. This request is needed to cover two part-time positions through the end of the fiscal year to assist the bureau in their daily operations.

<u>Traffic Operations (3009) 37.08% Federal Funds, 0.37% Intra-Agency Transfers, 2.03% Agency Indirect</u> <u>Cost Recovery and 60,52% Highway Funds</u>

Class 023 Decrease Heat-Electricity-Water by \$5,000. Funds are available in this class due to lower than budgeted expenses during FY2022.

Bridge Maintenance (3008) 31.61% Federal Funds, 6.20% Intra-Agency Transfers, 2.66% Agency Indirect Cost Recovery and 59.53% Highway Funds

- Class 046 Decrease Consultants by \$500. Lower than expected expenses in this class during FY2022 have produced this savings.
- Class 080 Increase Out of State Travel by \$500. This transfer is requested to cover travel expenses for an employee to attend the Northeast Bridge Preservation Partnership annual conference. The conference provides an opportunity to share and receive information on new techniques specific to our region to improve bridge preservation.

Central Operations (7026) 100% Turnpike Funds

Class 023 Increase Heat-Electricity-Water by \$20,000. The transfer is needed due to the increased costs associated with heating oil and electricity during FY2022.

East NH TPK Blue Star Operations (7031) 100% Turnpike Funds

- Class 023 Increase Heat-Electricity-Water by \$40,000. The transfer is needed due to the increased costs associated with heating oil and electricity during FY2022.
- Class 050 Decrease Personal Service Temp Appointment by \$70,000. Funds are available in this class due to lower than budgeted expenses during FY2022.

East NH TPK Blue Star Maintenance (7032) 0.93% Agency Income, 99.07% Turnpike Funds

Class 023 Increase Heat-Electricity-Water by \$10,000. The transfer is needed due to the increased costs associated with heating oil and electricity during FY2022.

The following is provided in accordance with the Budget Officer's instructional memorandum dated April 17, 1985 to support the above requested actions:

- 1. Does transfer involve continuing programs or one-time projects?

 This transfer is for continuing programs (not one-time).
- 2. Is this transfer required to maintain existing program level or will it increase program level? This transfer is to maintain existing program levels (no increase in program level).
- Cite any requirements, which make this program necessary.
 RSA 21-L:2, in part, establishes that the Department will be responsible for planning, developing, and maintaining a state transportation network. This transfer will facilitate the accomplishment of this responsibility.
- Identify the source of funds on all accounts listed on this transfer.
 The source of funds are Federal Funds, Agency Income, Intra-Agency Income, Agency Indirect Cost Recovery Funds, Tumpike Funds, and Highway Funds.
- 5. Will there be any effect on revenue if this transfer is approved or disapproved? This transfer will have no effect on revenue.
- 6. Are funds expected to lapse if this transfer is not approved? Should funds lapse as a result of not approving this transfer request, such funds will lapse to their respective account fund balances.
- 7. Are personal services involved?

 This transfer does not result in any new full-time positions.
