#### REQUESTED ACTION

- 1. Pursuant to RSA 14:30-a, VI, authorize the Department of Health and Human Services, Division for Behavioral Health, Bureau of Drug & Alcohol Services to accept and expend Medication Assisted Treatment federal funds from the Substance Abuse and Mental Health Services Administration in the amount of \$320,015 effective upon date of Fiscal Committee and Governor and Executive Council approval, through June 30, 2017, and further authorize the funds to be allocated as follows. Grant funds awarded for periods after SFY 2017 will be included in the future operating budgets for SFY 2018 and SFY 2019. 100% Federal Funds.
- Pursuant to the provisions of NH RSA 124:15, Positions Restricted, and subject to the approval
  of item 1 above, authorize the Department of Health and Human Services, Division for
  Behavioral Health, Bureau of Drug & Alcohol Services to establish one position utilizing
  Medication Assisted Treatment grant funds effective upon date of approval by the Fiscal
  Committee and Governor and Council, through June 30, 2017.

#### **EXPLANATION**

The Department of Health and Human Services, Division for Behavioral Health, Bureau of Drug & Alcohol Services seeks approval to accept and expend Medication Assisted Treatment (MAT) Grant funds in the amount of \$320,015 from the Substance Abuse and Mental Health Services Administration. This request represents year 1 of a multi-year grant (September 1, 2016 – August 31, 2019). This grant does not have a matching funds requirement. A copy of the grant award is attached.

The Medication Assisted Treatment grant will be used to deliver MAT expansion services to 1,400 residents within three years, in the high risk, high need communities of Nashua and Manchester. MAT expansion will invest in patient-centered, effective, comprehensive integrated MAT services at the Manchester Community Health Center and Harbor Homes Harborcare Health and Wellness Center. These federally qualified health centers will expand their provision of MAT services and partner with local specialty substance use disorder and recovery support providers to provide patients access to care planning, coordination and delivery of care which is integrated and meets physical health, substance use disorder and co-occurring mental health service needs. The health centers will lead integrated efforts to outreach to diverse high risk populations, assess, diagnose and treatment plan, provide MAT services and access peer recovery coaches and other recovery support services.

The purpose of MAT expansion is to reduce the number of NH residents with untreated and under-treated opioid use disorders which will be met by achieving four key goals:

- 1. Increasing the number of NH residents with opioid use disorders receiving integrated MAT in Nashua and Manchester through health center expansion of MAT service delivery to 1,400 patients by September 2019.
- 2. Supporting the expansion of capacity for the provision of integrated MAT services through training of MAT teams and providers, modification of electronic health records, and implementation of the MAT Community of Practice to support MAT practice expansion, best practice adoption and the aggregation of lessons learned.
- 3. Reducing opioid use among participating patients by retaining 55% of patients in integrated MAT for at least 6 months and evidencing that 45% of participating patients reduce opioid use at 6 month follow-up.
- 4. Developing sustainable, adequate reimbursement mechanisms for patient-centered effective integrated MAT service delivery by utilizing the Governor's Commission on Alcohol and Drug Abuse Prevention, Treatment and Recovery as an advisory group with key policy makers, implementers, and community representatives and the creation and dissemination of policy improvement recommendations regarding adequate reimbursement amounts and mechanisms for sustaining integrated MAT services by October 2018, thereby facilitating the necessary changes in the current system.

2) Nature, need and duration:

Full-time, Temporary Program Specialist IV, LG 25, Position # 9T2893

Program Specialist IV position is essential to provide coordination and management of the Medication Assisted Treatment – Prescription Drug and Opioid Addiction (MAT-PDOA) Project by planning the development and modification of data, policies and procedures and evaluating the work product of state and local programs providing services in accordance with the MAT-PDOA Project. The duration of the position is through the length of the project period, August 31, 2019.

3) Relationship to existing agency programs:

The MAT-PDOA Project will significantly increase the capacity and accessability to Medication Assisted Treatment for people with opioid use disorders in NH's largest urban areas serving high need populations. The identified health centers will develop their treatment services according to the standards for MAT that are being promoted in all areas of the state and will complement existing MAT development in hospital-based primary care practices in other regions.

- 4) Has similar program been requested of the Legislature and denied? No
- 5) Why wasn't funding included in the agency's budget request?

These funds were awarded effective September 1, 2016. It was not known that these funds would be available at the time the agency established its SFY 2016-2017 biennial budget. The grant is included in the SFY 2018-2019 biennial budget request.

6) Can portions of the grant funds be utilized for other purposes?
