## **REQUESTED ACTION**

Pursuant to RSA 14:30-a, VI, authorize the Department of Justice to accept and expend a grant in the amount of \$6,966,979.00 from the Office of Justice Programs, Office for Victims of Crime to be utilized to support programs for victims of crime from the date of the Fiscal Committee of the General Court and Governor and Executive Council approvals through June 30, 2017. 100% Federal Funds

Funds are to be budgeted in 02-20-201510-5021000, Department of Justice, Grants Administration, titled Victims of Crime Act (Job #20VOC16A) as follows:

## **EXPLANATION**

The Victim of Crime Act (VOCA) grant is awarded to provide direct services to New Hampshire victims of crime. The Department of Justice (DOJ) originally budgeted \$2,500,000 in SFY 2017 in anticipation of the normally consistent VOCA grant. Recent changes to federal policies and procedures regarding the Federal Fiscal Year 2015 and Federal Fiscal Year 2016 grants increased funding substantially.

As recommended by the Federal Office for Victims of Crime, the DOJ increased grant funding by approximately \$6 million to existing proven programs providing direct services to victims of crime. These programs include, but are not limited to, the New Hampshire Coalition Against Domestic and Sexual Violence and its fourteen member agencies, Court Appointed Special Advocates of NH, Child Advocacy Centers, County Victim Advocates, Northern Human Services and other support and training programs directly servicing victims of crime.

Expanded federal guidelines also allowed the DOJ to focus on underserved populations through the creation of an Elder Abuse Unit at DOJ, by granting approximately \$1.6 million to legal assistance agencies specializing in working with underserved populations, and by providing grants for additional county victim advocates.

The DOJ is also soliciting grant applications through an RFP in the amount of \$3.6 million for victim services with a focus on child abuse, sexual assault and domestic violence. This RFP will be open to new and existing programs to create and enhance such services in the State.

Federal award funds are budgeted to support the activities as follows:

041-500801: Audit fund set aside.

072-500575: Federal grants to be awarded to sub recipient organizations to support VOCA program activities.

In the event that federal funds become no longer available, general funds will not be requested to support this program.

#### SPECIAL CONDITIONS

### 1. Applicability of Part 200 Uniform Requirements

27. Discrimination Findings
