EXPLANATION

The Board of Alcohol and Other Drug Abuse Professionals generate revenues through licensing examination fees paid by new applicants. The money collected from the initial application fee is deposited into the Board's Unrestricted Revenue Account and is 100% General Funds.

The Board in turn incurs expenses for the examinations administered to the new applicants. This year the Board budgeted for \$1,500 examinations but has received a significantly higher number of requests for examinations. The Board, by virtue of RSA 332-G:2, wishes at this time to recognize the additional revenue from the examination fees and in return expend additional Class 20 funds for the necessary examinations. Without this request being granted, the Board's Class 20 will be negative.

CHAPTER 332-G
GENERAL ADMINISTRATION OF REGULATORY
BOARDS AND COMMISSIONS

Section 332-G:2

332-G:2 Examination Fees. – Boards or commissions which administer or require examinations as part of examination for licensure and which establish charges to examination applicants equivalent to 125 percent of the direct expense of the examination may expend funds for such examinations, related services, or supplies as needed, but not to exceed the direct expense of the examination.
