**REQUESTED ACTION**

Pursuant to RSA 4:8, authorize the Department of Natural and Cultural Resources, Division of Parks and Recreation, Cannon Mountain Aerial Tramway & Ski Area to accept a donation of goods and services toward the completion of the summit patrol hut, valued at \$25,000, from the Franconia Notch Ski Patrollers' Association, a registered New Hampshire 501c3 based in Franconia, upon Governor and Executive Council approval.

**EXPLANATION**

The Franconia Notch Ski Patrollers' Association is an established non-profit ski patrol organization partnering with Cannon Mountain. The organization is stewarded by current and previous Cannon Mountain Ski Patrol (CMSP) members. As a gesture of support for the newly established summit patrol hut recently constructed, they seek to donate in perpetuity to Cannon Mountain, goods and services valued at \$25,000 toward the completion of the Cannon Mountain summit patrol hut interior construction. This donation will ensure availability of use of the new facility to be ready for the 2018-19 winter season. There is no expectation of ownership or privileged use attached to said donation.

Franconia Notch Ski Patrol Association (FNSPA) has agreed to complete the interior finish and build-out of the new ski patrol station at the summit of Cannon Mountain. This is a donation; there is no expectation of ownership or privileged use.

This project will include interior flooring, electrical, heating, lighting, insulation, and drywall installation and finishing. We have entered into this partnership with Cannon so that Cannon Mountain Ski Patrol will be able to use this facility for the approaching 2018-19 winter season.
