REQUESTED ACTION

Authorize the Department of Health and Human Services, Office of the Commissioner to make a **retroactive** one-time payment from State Fiscal Year (SFY) 2020 funds to Cheri Leach, Adult Protective Service Worker II in the amount of \$1701.57. This payment is to compensate the employee for wages that were not paid for State Fiscal Year 2019. The funds to be paid will be eighty-five percent (85%) General Funds, fifteen percent (15%) Federal Funds. Funds are available in the following account as follows:

EXPLANATION
