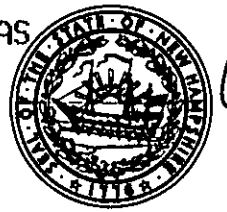

REQUESTED ACTION

Authorize the Department of Environmental Services (DES) to make **RETROACTIVE, UNENCUMBERED** payment of invoices totaling \$140,201.77 to the following entities for emergency response and temporary measures undertaken to repair the Winnepesaukee River Basin Program's 24-inch sewer force main located in Laconia near Pendleton Beach. 100% WRBP Funds.

EXPLANATION

This request is for **RETROACTIVE** payment by the Winnepesaukee River Basin Program (WRBP) to reimburse expenses incurred during the emergency response to stop the sewage leaking from the sewer line located along Pendleton Beach Road in Laconia. This sewer force main became operational in 1982 after this portion of the WRBP wastewater collection system was constructed. A sewage leak was discovered coming from the 24-inch diameter ductile iron sewer force main on April 20, 2019. The emergency response measures that are the subject of this request, allowed a timely and effective response to stop the sewer leak to the environment and allow time to formulate a permanent repair for the sewer line.

Septic haulers and bypass pumping were required to stop the flow through the pipeline and subsequent excavation of the sewer line determined the leaking was from perforations starting from the outside of the pipe caused by adverse soil conditions in the area. A temporary, partial patch was put on the pipeline

but this patch was not the necessary, complete repair since the pipeline was degraded along the bottom in more than one location. Therefore, at this time, the pipeline remains non-operational with bypass pumping continuing while a permanent solution is being developed.

Itemized expenses are attached for emergency response expenses incurred to date including one of the septic haulers that provided extensive bypass hauling around the location of the leak, deployment and initial response by the excavation contractor, and materials/supplies needed for the temporary repairs.

In the near future, a request will be made for the expenses to perform the permanent repairs which are expected to require additional, limited excavation and installation of an engineered cured-in-place lining for approximately 700 feet of the sewer forcemain located in the same suspect soil conditions. This solution is not only cost effective, but is the preferred option since it does not require excavation and replacement of the entire pipeline, will limit damage to Pendleton Beach Road and abutting properties, and minimize disruption of the largely residential neighborhood.

All of the WRBP's expenses are paid by the users of the system; there is no General Fund contribution to the WRBP budget.

We respectfully request your authorization to pay the attached invoices.
