**NHDP'S REPLY TO SHAWN O'CONNOR'S OBJECTION TO NHDP'S MOTION FOR RECONSIDERATION**

NOW COMES the New Hampshire Democratic Party, by and through counsel, Shaheen & Gordon, P.A., filing its reply to Shawn O'Connor's Objection to NHDP's Motion for Reconsideration, and, in support thereof, states as follows:

1. On September 19, 2016, the New Hampshire Democratic Party ("NHDP") filed a Motion for Reconsideration on the grounds that the Ballot Law Commission misapprehended a point of fact or law when it relied on the statement from the Secretary of State's Office that the nomination paper for individuals candidate do not notify potential signors of the provisions set forth in RSA 655:40. As established in the Motion for Reconsideration, this statement was incorrect and material to the Commission's resolution of the matter.<sup>1</sup>

2. On September 20, 2016, Shawn O'Connor filed his Objection to the Motion for Reconsideration. Mr. O'Connor claims that the nomination paper containing the notice provision set forth in RSA 655:40 was not available at the time his campaign downloaded nomination papers on an undisclosed date. See Objection at ¶ 16. Mr. O'Connor proffers he will

submit affidavits to support this contention. Id. Mr. O'Connor's representations are suspect at best.

3. Mr. O'Connor announced his independent candidacy on June 9, 2016. See Ex. 1.

4. The nomination paper attached as Exhibit 2 to the Motion for Reconsideration containing the notice provision of RSA 655:40 has been on the Secretary of State's website since at least April 18, 2016. See Ex. 1. As of that date, the two forms of the nomination papers were available side-by-side on the website. Id. (page 2 of 3, URLs ending 50568 and 50567). Both forms were also available as of July 11, 2016. See Ex. 2. Accordingly, any representation that this version of the form was not available when Mr. O'Connor began his independent candidacy or during the petition process is simply not credible.

5. Additionally, the URLs for the nomination papers available on the Secretary of State's website are in sequential order ending in the following digits:

50566 (nomination paper for multi-candidates with notice provision);

50567 (nomination paper for individual candidate without notice provision);

50568 (nomination paper for individual candidate with notice provision); and

50569 (nomination paper for multi-candidate with notice provision).

6. Mr. O'Connor would have the Commission believe that at the time his campaign downloaded the form at 50567, the Secretary of State's Office had posted all of these links but for 50568 and had intentionally did not use the URL ending in 50568 so it could be added at a later date. This assertion is not credible.

7. Mr. O'Connor also questions whether the Commission may reconsider a point of law that it overlooked or misapprehended. The Administrative Procedures Act allows Commissions to act as adjudicatory bodies. The rules promulgated by the Department of Justice

allow for motions for reconsideration. Additionally, a party appearing before a Commission has a due process right to have adjudicatory matters resolved on determination of facts that are accurate and not false or in error. It cannot be debated that the statement from the Secretary of State's Office was incorrect and material to the Commission's decision. Mr. O'Connor states there is no relief from such an error. By way of example, if individual testimony that was relied upon by the Commission was determined to be intentionally false and perjurious immediately after the decision was rendered, Mr. O'Connor claims the Commission cannot reconsider its decision based upon a presentation of truthful information. This is absurd. Although we do not suggest the statement to the Commission was intentionally false in any way, NHDP has presented evidence that the statement was incorrect. Because the incorrect statement was material to the Commission's decision, it must be reconsidered and the decision should be reversed.


